A BILL

To amend the Federal Election Campaign Act of 1971 to prohibit the misrepresentation of actions on behalf of candidates, political parties, and political committees and organizations, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Stop Scam PACs Act”.

5 **SEC. 2. PROHIBITING MISREPRESENTATION OF ACTION.**

6 (a) COVERAGE OF ALL MISREPRESENTATION OF AC-

7 TION ON BEHALF OF CANDIDATES, POLITICAL PARTIES,

8 AND POLITICAL COMMITTEES AND ORGANIZATIONS.—

1 Section 322 of the Federal Election Campaign Act of
2 1971 (52 U.S.C. 30124) is amended—

3 (1) in the heading, by striking “FRAUDULENT”;

4 (2) in subsection (a)—

5 (A) by striking “who is a candidate for
6 Federal office or an employee or agent of such
7 a candidate”; and

8 (B) in paragraph (1)—

9 (i) by striking “fraudulently”;

10 (ii) by striking “under his control”;

11 and

12 (iii) by striking “other candidate or
13 political party or employee or agent thereof
14 on a matter which is damaging to such
15 other candidate or political party or em-
16 ployee or agent thereof” and inserting
17 “real, potential, spurious, or non-existent
18 candidate, political party, or political com-
19 mittee or organization, or employee or
20 agent of any such candidate, political
21 party, or political committee or organiza-
22 tion”; and

23 (3) in subsection (b)—

24 (A) in the heading, by striking “FRAUDU-
25 LENT”; and

1 (B) in paragraph (1)—

2 (i) by striking “fraudulently”; and

3 (ii) by striking “candidate or political
4 party or employee or agent thereof for the
5 purpose of soliciting contributions or dona-
6 tions” and inserting “real, potential, spu-
7 rious, or non-existent candidate, political
8 party, or political committee or organiza-
9 tion, or employee or agent of any such can-
10 didate, political party, or political com-
11 mittee or organization when soliciting
12 money or any other thing of value”.

13 (b) EFFECTIVE DATE.—The amendments made by
14 subsection (a) shall take effect upon the expiration of the
15 90-day period which begins on the date of the enactment
16 of this Act.
