## A BILL

To direct all specified new employees of the IRS to assist with the processing through the immigration system of aliens unlawfully present in the United States, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Bureaucrats to the  
5 Border Act”.

1 **SEC. 2. DHS VOLUNTEER FORCE RENAMED DHS MISSION**  
2 **SUPPORT FORCE.**

3 The DHS Volunteer Force of the Office of the Chief  
4 Human Capital Officer of the Department of Homeland  
5 Security shall be known, on and after the date of the en-  
6 actment of this Act, as the “DHS Mission Support  
7 Force”, and any reference to the DHS Volunteer Force  
8 in any law, regulation, rule, guidance, paper, map, or  
9 other document of the United States shall be deemed to  
10 be a reference to the DHS Mission Support Force.

11 **SEC. 3. NEW EMPLOYEES OF THE IRS TO PROVIDE SUP-**  
12 **PORT AT SOUTHERN UNITED STATES BOR-**  
13 **DER.**

14 (a) IN GENERAL.—The Secretary of the Treasury  
15 shall require any specified new employee of the Internal  
16 Revenue Service to complete a 30-day support detail with  
17 the DHS Mission Support Force within 365 days of the  
18 date of hire of such specified new employee.

19 (b) DEFINITIONS.—For purposes of this section—

20 (1) SPECIFIED NEW EMPLOYEE.—The term  
21 “specified new employee” means any employee  
22 who—

23 (A) is hired as a result of the funding in-  
24 crease for enhancement of Internal Revenue  
25 Service resources under clause (ii) or (iii) of

1 section 10301(1)(A) of the Inflation Reduction  
2 Act, and

3 (B) who meets the employment standards  
4 of the DHS Mission Support Force.

5 (2) SUPPORT DETAIL.—The term “support de-  
6 tail” means a detail with either U.S. Customs and  
7 Border Protection or U.S. Immigration and Customs  
8 Enforcement for the purpose of providing assistance  
9 at the southern border with the processing through  
10 the immigration system of aliens unlawfully present  
11 in the United States.
