A BILL

To direct the Attorney General to establish and carry out
a Veteran Treatment Court Program.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Veteran Treatment
5 Court Coordination Act of 2019”.

6 **SEC. 2. SENSE OF CONGRESS.**

7 It is the sense of Congress that veterans treatment
8 courts are a successful program aimed at helping veterans
9 charged with non-violent crimes receive the help and the
10 benefits for which the veterans are entitled.

11 **SEC. 3. VETERAN TREATMENT COURT PROGRAM.**

12 (a) ESTABLISHMENT.—Subject to the availability of
13 appropriations, in coordination with the Secretary of Vet-
14 erans Affairs, the Attorney General shall establish and
15 carry out a Veteran Treatment Court Program to provide
16 grants and technical assistance to the State circuit court
17 systems that—

18 (1) have adopted a Veterans Treatment Court
19 Program; or

20 (2) have filed a notice of intent to establish a
21 Veterans Treatment Court Program with the Sec-
22 retary.

23 (b) PURPOSE.—The purpose of the Veterans Treat-
24 ment Court Program established under subsection (a) is
25 to ensure the Department of Justice has a single office

1 to coordinate the provision of grants, training, and tech-
2 nical assistance to help State, local, and Tribal govern-
3 ments to develop and maintain veteran treatment courts.

4 (c) PROGRAMS INCLUDED.—The Veterans Treatment
5 Court Program established under subsection (a) shall in-
6 clude the grant programs relating to veterans treatment
7 courts carried out by the Attorney General pursuant to
8 sections 2901, 2991, and 3021 of the Omnibus Crime
9 Control and Safe Streets Act of 1968 (34 U.S.C. 10581,
10 10651, and 10701) or any other provision of law.

11 (d) REGULATIONS.—The Attorney General shall pro-
12 mulgate regulations to carry out this section.
