A BILL

To establish a grant program to encourage the use of assistance dogs by certain members of the Armed Forces and veterans.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "K–9 Companion Corps
- 5 Act".

1 SEC. 2. WOUNDED WARRIOR K-9 CORPS.

2	(a) Grants Authorized.—Subject to the avail-
3	ability of appropriations provided for such purpose, the
4	Secretary of Defense and the Secretary of Veterans Af-
5	fairs shall jointly establish a program, to be known as the
6	"K-9 Companion Corps Program", to award competitive
7	grants to nonprofit organizations to assist such organiza-
8	tions in planning, designing, establishing, and operating
9	programs to provide assistance dogs to covered members
10	and veterans.
11	(b) Use of Funds.—
12	(1) In general.—The recipient of a grant
13	under this section shall use the grant to carry out
14	programs that provide assistance dogs to covered
15	members and veterans who have a disability de-
16	scribed in paragraph (2).
17	(2) DISABILITY.—A disability described in this
18	paragraph is any of the following:
19	(A) Blindness or visual impairment.
20	(B) Loss of use of a limb, paralysis, or
21	other significant mobility issues.
22	(C) Loss of hearing.
23	(D) Traumatic brain injury.
24	(E) Post-traumatic stress disorder.

1	(F) Any other disability that the Secretary
2	of Defense and the Secretary of Veterans Af-
3	fairs consider appropriate.
4	(c) Eligibility.—To be eligible to receive a grant
5	under this section, a nonprofit organization shall submit
6	an application to the Secretary of Defense and the Sec-
7	retary of Veterans Affairs at such time, in such manner,
8	and containing such information as the Secretary of De-
9	fense and the Secretary of Veterans Affairs may require.
10	Such application shall include—
11	(1) a proposal for the evaluation required by
12	subsection (d); and
13	(2) a description of—
14	(A) the training that will be provided by
15	the organization to covered members and vet-
16	erans;
17	(B) the training of dogs that will serve as
18	assistance dogs;
19	(C) the aftercare services that the organi-
20	zation will provide for such dogs and covered
21	members and veterans;
22	(D) the plan for publicizing the availability
23	of such dogs through a targeted marketing
24	campaign to covered members and veterans;

1	(E) the recognized expertise of the organi-
2	zation in breeding and training such dogs;
3	(F) the commitment of the organization to
4	comparable standards as that of the Inter-
5	national Guide Dog Federation or Assistance
6	Dogs International;
7	(G) the commitment of the organization to
8	humane standards for animals; and
9	(H) the experience of the organization with
10	working with military medical treatment facili-
11	ties or medical facilities of the Department of
12	Veterans Affairs.
13	(d) EVALUATION.—The Secretary shall require each
14	recipient of a grant to use a portion of the funds made
15	available through the grant to conduct an evaluation of
16	the effectiveness of the activities carried out through the
17	grant by such recipient.
18	(e) DEFINITIONS.—In this Act:
19	(1) The term "assistance dog" means a dog
20	specifically trained to perform physical tasks to miti-
21	gate the effects of a disability described in sub-
22	section (b)(2), except that the term does not include
23	a dog specifically trained for comfort or personal de-

fense.

1	(2) The term "covered members and veterans"
2	means—
3	(A) with respect to a member of the
4	Armed Forces, such member who is—
5	(i) receiving medical treatment, recu-
6	peration, or therapy under chapter 55 of
7	title 10, United States Code;
8	(ii) in medical hold or medical hold-
9	over status; or
10	(iii) covered under section 1202 or
11	1205 of title 10, United States Code; and
12	(B) with respect to a veteran, a veteran
13	who is enrolled in the health care system estab-
14	lished under section 1705(a) of title 38, United
15	States Code.
16	(f) Authorization of Appropriations.—There is
17	authorized to be appropriated to carry out this Act
