1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to consider in the House the joint resolu-
3 tion (H.J. Res. 43) providing for congressional dis-
4 approval under chapter 8 of title 5, United States Code,
5 of the final rule submitted by Secretary of Health and
6 Human Services relating to compliance with title X re-
7 quirements by project recipients in selecting subrecipients.
8 All points of order against consideration of the joint reso-
9 lution are waived. The joint resolution shall be considered
10 as read. All points of order against provisions in the joint
11 resolution are waived. The previous question shall be con-
12 sidered as ordered on the joint resolution and on any
13 amendment thereto to final passage without intervening
14 motion except: (1) one hour of debate equally divided and
15 controlled by the Majority Leader and the Minority Lead-
16 er or their respective designees; and (2) one motion to re-
17 commit.

18 SEC. 2. Upon adoption of this resolution it shall be
19 in order to consider in the House the joint resolution (H.J.
20 Res. 69) providing for congressional disapproval under

1 chapter 8 of title 5, United States Code, of the final rule
2 of the Department of the Interior relating to “Non-Sub-
3 sistence Take of Wildlife, and Public Participation and
4 Closure Procedures, on National Wildlife Refuges in Alas-
5 ka”. All points of order against consideration of the joint
6 resolution are waived. The joint resolution shall be consid-
7 ered as read. All points of order against provisions in the
8 joint resolution are waived. The previous question shall be
9 considered as ordered on the joint resolution and on any
10 amendment thereto to final passage without intervening
11 motion except: (1) one hour of debate equally divided and
12 controlled by the chair and ranking minority member of
13 the Committee on Natural Resources; and (2) one motion
14 to recommit.

15 SEC. 3. On any legislative day during the period from
16 February 17, 2017, through February 24, 2017—

17 (a) the Journal of the proceedings of the previous day
18 shall be considered as approved; and

19 (b) the Chair may at any time declare the House ad-
20 journed to meet at a date and time, within the limits of
21 clause 4, section 5, article I of the Constitution, to be an-
22 nounced by the Chair in declaring the adjournment.

23 SEC. 4. The Speaker may appoint Members to per-
24 form the duties of the Chair for the duration of the period

- 1 addressed by section 3 of this resolution as though under
- 2 clause 8(a) of rule I.
