Mr. BENTIVOLIO submitted the following resolution; which was referred to the Committee on Foreign Affairs

## RESOLUTION

Recognizing the 24th anniversary of the Tiananmen Square massacre, calling for the release of Dr. Wang Bingzhang, and for other reasons.

Whereas the freedoms of expression, assembly, and association are fundamental human rights and are recognized as such under the United Nations Declaration of Human Rights and the International Covenant on Civil and Political Rights;

Whereas the protests in Tiananmen Square were the result of the peaceful democratic movement throughout China and were calling for open dialogue with the Government of the People's Republic of China and its leaders regarding democratic reform;

Whereas the People's Liberation Army and other security forces used lethal force to disperse demonstrations in Beijing on June 3, 1989, and June 4, 1989;

Whereas the People's Liberation Army and other security forces wounded and killed thousands of innocent people;

Whereas thousands of people throughout China who were suspected of taking part in the democracy movement were arrested and sentenced without trial;

Whereas the Government of the People's Republic of China has become increasingly sophisticated in its persecution of religious groups, human rights and democracy advocates, and ethnic minorities;

Whereas the Government of the People's Republic of China kidnapped Dr. Wang Bingzhang, a United States permanent resident and one of the founders of the Chinese democracy movement, and sentenced him to life in prison on charges of espionage and terrorism in a closed trial, and whose detention was declared arbitrary by the United Nations Working Group on Arbitrary Detention;

Whereas the Government of the People's Republic of China continues to—

- (1) take active measures to deny citizens information regarding the Tiananmen Square massacre, and continues to suppress access to information about the event on the Internet;

- (2) harass, detain, or imprison members of the Chinese democracy movement and other advocates for democratic reform, human rights, and religious freedom;

- (3) oppress and persecute the peaceful, spiritual movement of Falun Gong and its leaders and practitioners; and

(4) restrict and censor free speech on the Internet;  
and

Whereas June 4, 2013, is the 24th anniversary of the  
Tiananmen Square massacre: Now, therefore, be it

1       *Resolved*, That the House of Representatives—

2           (1) expresses sympathy and condolences to the  
3 families of the victims who were killed, wounded,  
4 tortured, or imprisoned resulting from their partici-  
5 pation in the demonstrations in Tiananmen Square,  
6 Beijing, in the People’s Republic of China on June  
7 3, 1989, and June 4, 1989, and to the families of  
8 those who continue to face persecution, torture, or  
9 imprisonment as a result of their involvement with  
10 those demonstrations;

11          (2) commends and honors the advocates who  
12 continue to struggle for democracy and human  
13 rights in China, despite the harsh consequences they  
14 face;

15          (3) condemns the continued persecution and op-  
16 pression of peaceful religious minorities, such as  
17 Buddhists, the Uyghur people, Falun Gong practi-  
18 tioners, and other spiritual movements;

19          (4) condemns the ongoing human rights abuses  
20 and persecution by the Government of the People’s  
21 Republic of China and its efforts to quell political  
22 dissent and oppress religious minorities; and

1           (5) calls on the Government of the People's Re-  
2 public of China to—

3           (A) end the harassment, detention, torture,  
4 and imprisonment of Chinese citizens express-  
5 ing their legitimate freedom of religion, expres-  
6 sion, and association;

7           (B) release the remaining prisoners of con-  
8 science who continue to be detained as a result  
9 of their participation in the peaceful pro-democ-  
10 racy demonstrations in 1989, especially around  
11 Tiananmen Square;

12           (C) end the targeted persecution and op-  
13 pression of the Uyghur community, particularly  
14 the suppression of their religious faith;

15           (D) end the persecution of Falun Gong  
16 practitioners by the Government of the People's  
17 Republic of China and Chinese authorities; and

18           (E) release United States permanent resi-  
19 dent Dr. Wang Bingzhang, a long-time peaceful  
20 democracy activist, who was sentenced to life in  
21 prison on charges of terrorism and espionage,  
22 whose daughter, son, and sister are United  
23 States citizens.
