## RESOLUTION

Providing for consideration of the bill (H.R. 2) to secure the borders of the United States, and for other purposes, and providing for consideration of the bill (H.R. 1163) to provide incentives for States to recover fraudulently paid Federal and State unemployment compensation, and for other purposes.

- 1       *Resolved*, That upon adoption of this resolution it
- 2 shall be in order to consider in the House the bill (H.R.
- 3 2) to secure the borders of the United States, and for

1 other purposes. All points of order against consideration  
2 of the bill are waived. The bill shall be considered as read.  
3 All points of order against provisions in the bill are  
4 waived. The previous question shall be considered as or-  
5 dered on the bill and on any amendment thereto to final  
6 passage without intervening motion except: (1) five hours  
7 of debate, with two hours equally divided and controlled  
8 by the chair and ranking minority member of the Com-  
9 mittee on Homeland Security or their respective designees,  
10 two hours equally divided and controlled by the chair and  
11 ranking minority member of the Committee on the Judici-  
12 ary or their respective designees, and one hour equally di-  
13 vided and controlled by the chair and ranking minority  
14 member of the Committee on Foreign Affairs or their re-  
15 spective designees; and (2) one motion to recommit.

16       SEC. 2. Upon adoption of this resolution it shall be  
17 in order to consider in the House the bill (H.R. 1163)  
18 to provide incentives for States to recover fraudulently  
19 paid Federal and State unemployment compensation, and  
20 for other purposes. All points of order against consider-  
21 ation of the bill are waived. The amendment in the nature  
22 of a substitute recommended by the Committee on Ways  
23 and Means now printed in the bill, modified by the amend-  
24 ment printed in the report of the Committee on Rules ac-  
25 companying this resolution, shall be considered as adopt-

1 ed. The bill, as amended, shall be considered as read. All  
2 points of order against provisions in the bill, as amended,  
3 are waived. The previous question shall be considered as  
4 ordered on the bill, as amended, and on any further  
5 amendment thereto, to final passage without intervening  
6 motion except: (1) one hour of debate equally divided and  
7 controlled by the chair and ranking minority member of  
8 the Committee on Ways and Means or their respective des-  
9 ignees; and (2) one motion to recommit.
