Ms. SLAUGHTER submitted the following resolution; which was referred to the Committee on Rules

RESOLUTION

Providing for further consideration of the bill (H.R. 2847) making appropriations for the Departments of Commerce and Justice, and Science, and Related Agencies for the fiscal year ending September 30, 2010, and for other purposes.

1 *Resolved*, That during further consideration of the bill
2 (H.R. 2847) making appropriations for the Departments
3 of Commerce and Justice, and Science, and Related Agen-
4 cies for the fiscal year ending September 30, 2010, and
5 for other purposes, no further general debate shall be in

1 order. Notwithstanding clause 11 of rule XVIII and House
2 Resolution 544, and except as provided in section 2, no
3 further amendment shall be in order except: (1) amend-
4 ments numbered 3, 6, 19, 22, 25, 31, 35, 41, 59, 60, 62,
5 63, 69, 71, 93, 96, 97, 98, 100, 102, 111, 114, and 118
6 printed in the Congressional Record of June 15, 2009,
7 pursuant to clause 8 of rule XVIII, which may be offered
8 only by the Member who submitted it for printing or a
9 designee, and (2) not to exceed 10 of the following amend-
10 ments if offered by the ranking minority member of the
11 Committee on Appropriations or his designee: amend-
12 ments numbered 76, 77, 78, 79, 80, 81, 82, 83, 84, 85,
13 86, 87, 88, 89, 90, 91, 104, 105, 106, 107, and 108 print-
14 ed in the Congressional Record of June 15, 2009, pursu-
15 ant to clause 8 of rule XVIII. Each amendment listed in
16 this section shall be considered as read, shall be debatable
17 for 10 minutes equally divided and controlled by the pro-
18 ponent and an opponent, and shall not be subject to a
19 demand for division of the question in the House or in
20 the Committee of the Whole. All points of order against
21 such amendments are waived except that an amendment
22 may be offered only at the appropriate point in the read-
23 ing. At the conclusion of consideration of the bill for
24 amendment the Committee shall rise and report the bill
25 to the House with such amendments as may have been

1 adopted. The previous question shall be considered as or-
2 dered on the bill and amendments thereto to final passage
3 without intervening motion except one motion to recommit
4 with or without instructions.

5 SEC. 2. The chair and ranking minority member of
6 the Committee on Appropriations or their designees each
7 may offer one pro forma amendment to the bill for the
8 purpose of debate. Such amendment may be repeated, but
9 only after consideration of an amendment listed in the
10 first section of this resolution.

11 SEC. 3. The Chair may entertain a motion that the
12 Committee rise only if offered by the chair of the Com-
13 mittee on Appropriations or his designee. The Chair may
14 not entertain a motion to strike out the enacting words
15 of the bill (as described in clause 9 of rule XVIII).
