Mr. PERLMUTTER, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 4173) to provide for financial regulatory reform, to protect consumers and investors, to enhance Federal understanding of insurance issues, to regulate the over-the-counter derivatives markets, and for other purposes.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 2(b) of
3 rule XVIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-

1 ation of the bill (H.R. 4173) to provide for financial regu-
2 latory reform, to protect consumers and investors, to en-
3 hance Federal understanding of insurance issues, to regu-
4 late the over-the-counter derivatives markets, and for
5 other purposes. The first reading of the bill shall be dis-
6 pensed with. All points of order against consideration of
7 the bill are waived except those arising under clause 9 or
8 10 of rule XXI. The amendment printed in the report of
9 the Committee on Rules accompanying this resolution
10 shall be considered as adopted in the House and in the
11 Committee of the Whole. General debate shall be confined
12 to the bill, as amended, and shall not exceed three hours,
13 with two hours equally divided and controlled by the chair
14 and ranking minority member of the Committee on Finan-
15 cial Services, 30 minutes equally divided and controlled
16 by the chair and ranking minority member of the Com-
17 mittee on Agriculture, and 30 minutes equally divided and
18 controlled by the chair and ranking minority member of
19 the Committee on Energy and Commerce. After general
20 debate, the Committee of the Whole shall rise without mo-
21 tion. No further consideration of the bill shall be in order
22 except pursuant to a subsequent order of the House.

23 SEC. 2. During consideration of H.R. 4173 pursuant
24 to this resolution, the Chair of the Committee of the
25 Whole may entertain a motion that the Committee rise

- 1 only if offered by the chair of the Committee on Financial
- 2 Services or his designee.
