Mrs. SHAHEEN introduced the following bill; which was read twice and referred to the Committee on Veterans' Affairs

## A BILL

To require the Secretary of Veterans Affairs to improve the provision of services and benefits from the Department of Veterans Affairs for veterans who experience domestic violence or sexual assault, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Violence Against  
5 Women Veterans Act”.

1 **SEC. 2. PURPOSE.**

2 The purpose of this Act is to better integrate the  
3 medical, housing, mental health, and other benefits pro-  
4 vided by the Department of Veterans Affairs with existing  
5 community-based domestic violence and sexual assault  
6 services—

7 (1) to provide a more efficient and coordinated  
8 network of support for veterans experiencing domes-  
9 tic violence or sexual assault; and

10 (2) to better understand the impact of domestic  
11 violence and sexual assault on veterans, particularly  
12 female veterans.

13 **SEC. 3. PROGRAM TO ASSIST VETERANS WHO EXPERIENCE**  
14 **DOMESTIC VIOLENCE OR SEXUAL ASSAULT.**

15 (a) PROGRAM REQUIRED.—The Secretary of Vet-  
16 erans Affairs shall carry out a program to assist veterans  
17 that have experienced or are experiencing domestic vio-  
18 lence or sexual assault in accessing benefits from the De-  
19 partment of Veterans Affairs, including coordinating ac-  
20 cess to medical treatment centers, housing assistance, and  
21 other benefits from the Department.

22 (b) PARTNERSHIP.—The Secretary shall carry out  
23 the program under subsection (a) in partnership with—

24 (1) domestic violence shelters and programs;

25 (2) rape crisis centers;

1           (3) State domestic violence and sexual assault  
2           coalitions; and

3           (4) such other health care or other service pro-  
4           viders that serve domestic violence or sexual assault  
5           victims as determined by the Secretary, particularly  
6           those providing emergency services or housing assist-  
7           ance.

8           (c) AUTHORIZED ACTIVITIES.—In carrying out the  
9           program under subsection (a), the Secretary may conduct  
10          the following activities:

11           (1) Training for community-based domestic vio-  
12          lence or sexual assault service providers on—

13                   (A) identifying veterans who have been vic-  
14                   tims of domestic violence or sexual assault;

15                   (B) coordinating with local service pro-  
16                   viders of the Department; and

17                   (C) connecting veterans with appropriate  
18                   housing, mental health, medical, and other fi-  
19                   nancial assistance or benefits from the Depart-  
20                   ment.

21           (2) Assistance to service providers to ensure ac-  
22          cess of veterans to domestic violence and sexual as-  
23          sault emergency services, particularly in underserved  
24          areas, including services for members of Indian  
25          tribes.

1           (3) Such other outreach and assistance as the  
2 Secretary determines necessary for the provision of  
3 assistance under subsection (a).

4           (d) DOMESTIC VIOLENCE AND SEXUAL ASSAULT  
5 OUTREACH COORDINATORS.—

6           (1) IN GENERAL.—In order to effectively assist  
7 veterans who have experienced domestic violence or  
8 sexual assault, the Secretary may establish local co-  
9 ordinators to provide outreach under the program  
10 required by subsection (a).

11           (2) LOCAL COORDINATOR KNOWLEDGE.—The  
12 Secretary shall ensure that each coordinator estab-  
13 lished under paragraph (1) is knowledgeable about—

14                   (A) the dynamics of domestic violence and  
15 sexual assault, including safety concerns, legal  
16 protections, and the need for the provision of  
17 confidential services;

18                   (B) the eligibility of veterans for services  
19 and benefits from the Department that are rel-  
20 evant to recovery from domestic violence and  
21 sexual assault, particularly emergency housing  
22 assistance, mental health care, other health  
23 care, and disability benefits; and

24                   (C) local community resources addressing  
25 domestic violence and sexual assault.

1           (3) LOCAL COORDINATOR ASSISTANCE.—Each  
2           coordinator established under paragraph (1) shall  
3           assist domestic violence shelters and rape crisis cen-  
4           ters in providing services to veterans.

5 **SEC. 4. NATIONAL TASK FORCE ON VETERANS EXPERI-**  
6           **ENCING DOMESTIC VIOLENCE OR SEXUAL AS-**  
7           **SAULT.**

8           (a) IN GENERAL.—The Secretary of Veterans Af-  
9           fairs, in consultation with the Attorney General and the  
10          Secretary of Health and Human Services, shall establish  
11          a national task force (in this section referred to as the  
12          “Task Force”) to develop a comprehensive national pro-  
13          gram, including by integrating facilities, services, and ben-  
14          efits of the Department of Veterans Affairs into existing  
15          networks of community-based domestic violence and sex-  
16          ual assault services, to address domestic violence and sex-  
17          ual assault among veterans.

18          (b) CONSULTATION WITH STAKEHOLDERS.—In car-  
19          rying out this section, the Task Force shall consult with—

20               (1) representatives from not fewer than three  
21               national organizations or State coalitions with dem-  
22               onstrated expertise in domestic violence prevention,  
23               response, or advocacy; and

24               (2) representatives from not fewer than three  
25               national organizations or State coalitions, particu-

1 larly those representing underserved or ethnic mi-  
2 nority communities, with demonstrated expertise in  
3 sexual assault prevention, response, or advocacy.

4 (c) DUTIES.—The duties of the Task Force shall in-  
5 clude the following:

6 (1) To review existing services and policies of  
7 the Department and develop a comprehensive na-  
8 tional program to address domestic violence and sex-  
9 ual assault prevention, response, and treatment.

10 (2) To review the feasibility and advisability of  
11 establishing an expedited process to secure emer-  
12 gency, temporary benefits, including housing or  
13 other benefits, for veterans who are experiencing do-  
14 mestic violence or sexual assault.

15 (3) To review and make recommendations re-  
16 garding the feasibility and advisability of estab-  
17 lishing dedicated, temporary housing assistance for  
18 veterans experiencing domestic violence or sexual as-  
19 sault.

20 (4) To identify any requirements regarding do-  
21 mestic violence assistance or sexual assault response  
22 and services that are not being met by the Depart-  
23 ment and make recommendations on how the De-  
24 partment can meet such requirements.

1           (5) To review and make recommendations re-  
2           garding the feasibility and advisability of providing  
3           direct services or contracting for community-based  
4           services for veterans in response to a sexual assault,  
5           including through the use of sexual assault nurse ex-  
6           aminers, particularly in underserved or remote  
7           areas, including services for members of Indian  
8           tribes.

9           (6) To review the availability of counseling serv-  
10          ices provided by the Department and through peer  
11          network support, and to provide recommendations  
12          for the enhancement of such services, to address—

13                 (A) the perpetration of domestic violence  
14                 and sexual assault; and

15                 (B) the recovery of veterans, particularly  
16                 female veterans, from domestic violence and  
17                 sexual assault.

18          (7) To review and make recommendations to  
19          expand services available for veterans at risk of per-  
20          petrating domestic violence.

21          (d) REPORT.—Not later than one year after the date  
22          of the enactment of this Act, and not less frequently than  
23          annually thereafter, the Task Force shall submit to the  
24          Secretary of Veterans Affairs and Congress a report on

1 the activities of the Task Force, including any rec-  
2 ommendations for legislative or administrative action.

3 **SEC. 5. NATIONAL BASELINE STUDY ON PROBLEM OF DO-**  
4 **MESTIC VIOLENCE AND SEXUAL ASSAULT**  
5 **AMONG VETERANS AND SPOUSES OF VET-**  
6 **ERANS.**

7 The Secretary of Veterans Affairs, in consultation  
8 with the Attorney General, shall conduct a national base-  
9 line study to examine the scope of the problem of domestic  
10 violence and sexual assault among veterans and spouses  
11 of veterans.
