A BILL

To require the Secretary of Agriculture to enter into a property conveyance with the city of Wallowa, Oregon, and for other purposes.

1 Be it enacted by the Senate and House of Representa-

3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Wallowa Forest Service

5 Compound Conveyance Act".

1	SEC. 2. CONVEYANCE TO CITY OF WALLOWA, OREGON.

11	the historic values of the Wallowa Forest Service
12	Compound.
13	(e) REVERSION.—In the quitclaim deed to the City, the
14	Secretary shall provide that the Wallowa Forest Service
15	Compound shall revert to the Secretary, at the election of
16	the Secretary, if any of the conditions under subsection (c)
17	or (d) are violated.
