A BILL

For the relief of Guy Privat Tape and Lou Nazie Raymonde Toto.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. PERMANENT RESIDENT STATUS FOR GUY
- 4 PRIVAT TAPE AND LOU NAZIE RAYMONDE
- **5 TOTO.**
- 6 (a) In General.—Notwithstanding subsections (a)
- 7 and (b) of section 201 of the Immigration and Nationality
- 8 Act (8 U.S.C. 1151), Guy Privat Tape and Lou Nazie
- 9 Raymonde Toto shall each be eligible for the issuance of
- 10 an immigrant visa or for adjustment of status to that of
- 11 an alien lawfully admitted for permanent residence upon

- 1 filing an application for issuance of an immigrant visa
- 2 under section 204 of such Act (8 U.S.C. 1154) or for ad-
- 3 justment of status to lawful permanent resident.
- 4 (b) Adjustment of Status.—If Guy Privat Tape
- 5 or Lou Nazie Raymonde Toto enters the United States
- 6 before the filing deadline specified in subsection (c), Guy
- 7 Privat Tape or Lou Nazie Raymonde Toto, as appropriate,
- 8 shall be considered to have entered and remained lawfully
- 9 in the United States and shall be eligible for adjustment
- 10 of status under section 245 of the Immigration and Na-
- 11 tionality Act (8 U.S.C. 1255) as of the date of the enact-
- 12 ment of this Act.
- 13 (c) Application and Payment of Fees.—Sub-
- 14 sections (a) and (b) shall apply only if the application for
- 15 the issuance of an immigrant visa or the application for
- 16 adjustment of status is filed with appropriate fees not
- 17 later than 2 years after the date of the enactment of this
- 18 Act.
- 19 (d) Reduction of Immigrant Visa Numbers.—
- 20 Upon granting an immigrant visa or permanent residence
- 21 to Guy Privat Tape and Lou Nazie Raymonde Toto, the
- 22 Secretary of State shall instruct the proper officer to re-
- 23 duce by 2, during the current or subsequent fiscal year,
- 24 the total number of immigrant visas that are made avail-
- 25 able to natives of the country of birth of Guy Privat Tape

- 1 and Lou Nazie Raymonde Toto under section 203(a) of
- 2 the Immigration and Nationality Act (8 U.S.C. 1153(a))
- 3 or, if applicable, the total number of immigrant visas that
- 4 are made available to natives of the country of birth of
- 5 Guy Privat Tape and Lou Nazie Raymonde Toto under
- 6 section 202(e) of such Act (8 U.S.C. 1152(e)).
- 7 (e) PAYGO.—The budgetary effects of this Act, for
- 8 the purpose of complying with the Statutory Pay-As-You-
- 9 Go Act of 2010, shall be determined by reference to the
- 10 latest statement titled "Budgetary Effects of PAYGO
- 11 Legislation" for this Act, submitted for printing in the
- 12 Congressional Record by the Chairman of the Senate
- 13 Budget Committee, provided that such statement has been
- 14 submitted prior to the vote on passage.
