## A BILL

To amend title II of the Social Security Act to require the Commissioner of Social Security to use the Consumer Price Index for Elderly Consumers for purposes of determining cost-of-living adjustments under titles II, VIII, and XVI of the Social Security Act, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Boosting Benefits and  
5 COLAs for Seniors Act”.

1   **SEC. 2. MORE ACCURATE COST-OF-LIVING ADJUSTMENT.**

2           (a) IN GENERAL.—

3               (1) IN GENERAL.—Section 215(i)(1)(D) of the  
4             Social Security Act (42 U.S.C. 415(i)(1)(D)) is  
5             amended by striking “Consumer Price Index” and all that follows through “such index” and inserting  
6             “Consumer Price Index for Urban Wage Earners  
7             and Clerical Workers (CPI-W, as published by the  
8             Bureau of Labor Statistics of the Department of  
9             Labor) or Consumer Price Index for Elderly Con-  
10           sumers (CPI-E, as published by such Bureau)  
11           (whichever such index results in the higher percent-  
12           age under this subparagraph) exceeds the same such  
13           index”.

15               (2) CONFORMING AMENDMENT.—Section  
16             215(i)(1)(G) of the Social Security Act (42 U.S.C.  
17             415(i)(1)(G)) is amended by inserting “applicable  
18             for purposes of subparagraph (D)” after “Consumer  
19             Price Index”.

20           (b) APPLICATION TO PRE-1979 LAW.—

21               (1) IN GENERAL.—Section 215(i) of the Social  
22             Security Act as in effect in December 1978, and as  
23             applied in certain cases under the provisions of such  
24             Act as in effect after December 1978, is amended—

25                       (A) in paragraph (1)(B), by striking “Con-  
26                     sumer Price Index” and all that follows through

1       “such index” and inserting “Consumer Price  
2       Index for Urban Wage Earners and Clerical  
3       Workers (CPI-W, as published by the Bureau  
4       of Labor Statistics of the Department of  
5       Labor) or Consumer Price Index for Elderly  
6       Consumers (CPI-E, as published by such Bu-  
7       reau of such Department) (whichever such  
8       index results in the higher per centum under  
9       this subparagraph) exceeds, by not less than 3  
10      per centum, the same such Index”; and

11      (B) in paragraph (2)—

12       (i) in subparagraph (A)(ii), by strik-  
13       ing “Consumer Price Index for such cost-  
14       of-living computation quarter” and insert-  
15       ing “Consumer Price Index applicable for  
16       such year under paragraph (1)(B)”;

17       (ii) in subparagraph (C)(i), by strik-  
18       ing “Consumer Price Index as published  
19       for any month exceeds by 2.5 percent or  
20       more the level of such index” and inserting  
21       “Consumer Price Index for Urban Wage  
22       Earners and Clerical Workers or Consumer  
23       Price Index for Elderly Consumers as pub-  
24       lished for any month exceeds by 2.5 per-  
25       cent or more the level of such index”.

1                             (2) CONFORMING CHANGES.—Section 215(i)(4)  
2                             of the Social Security Act (42 U.S.C. 415(i)(4)) is  
3                             amended—

4                                 (A) by striking “and by section 9001” and  
5                             inserting “, section 9001”; and  
6                                 (B) by inserting “and section 2 of the  
7                             Boosting Benefits and COLAs for Seniors Act,”  
8                             after “1986.”.

9                             (c) NO EFFECT ON ADJUSTMENTS UNDER OTHER  
10                            LAWS.—Section 215(i) of the Social Security Act (42  
11                            U.S.C. 415(i)) is amended by adding at the end the fol-  
12                            lowing:

13                             “(6) With respect to any provision of law (other than  
14                             in this title, title VIII, or title XVI) which provides for  
15                             an adjustment of an amount under such provision of law  
16                             in the same percentage as a cost-of-living adjustment ap-  
17                             plied to benefit amounts under this title, such provision  
18                             of law shall be applied and administered as if the percent-  
19                             age of such cost-of-living adjustment applied to benefit  
20                             amounts under this title were determined without regard  
21                             to the amendments made by subsections (a) and (b) of  
22                             section 2 of the Boosting Benefits and COLAs for Seniors  
23                             Act.”.

24                             (d) PUBLICATION OF CONSUMER PRICE INDEX FOR  
25                             ELDERLY CONSUMERS.—The Bureau of Labor Statistics

1 of the Department of Labor shall prepare and publish an  
2 index for each calendar month to be known as the “Con-  
3 sumer Price Index for Elderly Consumers” that indicates  
4 changes over time in expenditures for consumption which  
5 are typical for individuals in the United States who have  
6 attained age 62.

7 (e) TRANSITION RULE.—Prior to the publication of  
8 the Consumer Price Index for Elderly Consumers (CPI–  
9 E) pursuant to subsection (d), the reference to such index  
10 made in each of the amendments made by subsections (a)  
11 and (b) shall be deemed to be a reference to the research  
12 price index prepared by the Bureau of Labor Statistics  
13 of the Department of Labor known as the Consumer Price  
14 Index for Americans 62 years of age and older (R–CPI–  
15 E).

16 (f) EFFECTIVE DATE.—The amendments made by  
17 this section shall apply to determinations made with re-  
18 spect to cost-of-living computation quarters (as defined in  
19 section 215(i)(1)(B) of the Social Security Act (42 U.S.C.  
20 415(i)(1)(B))) ending on or after September 30, 2024.
