## A BILL

To amend title 38, United States Code, to provide for coverage under the beneficiary travel program of the Department of Veterans Affairs of certain disabled veterans for travel in connection with certain special disabilities rehabilitation, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. COVERAGE UNDER DEPARTMENT OF VET-**  
2 **ERANS AFFAIRS BENEFICIARY TRAVEL PRO-**  
3 **GRAM OF TRAVEL IN CONNECTION WITH**  
4 **CERTAIN SPECIAL DISABILITIES REHABILI-**  
5 **TATION.**

6 (a) IN GENERAL.—Section 111(b)(1) of title 38,  
7 United States Code, is amended by adding at the end the  
8 following new subparagraph:

9 “(G) A veteran with vision impairment, a vet-  
10 eran with a spinal cord injury or disorder, or a vet-  
11 eran with double or multiple amputations whose  
12 travel is in connection with care provided through a  
13 special disabilities rehabilitation program of the De-  
14 partment (including programs provided by spinal  
15 cord injury centers, blind rehabilitation centers, and  
16 prosthetics rehabilitation centers) if such care is pro-  
17 vided—

18 “(i) on an in-patient basis; or

19 “(ii) during a period in which the Sec-  
20 retary provides the veteran with temporary  
21 lodging at a facility of the Department to make  
22 such care more accessible to the veteran.”.

23 (b) REPORT.—Not later than 180 days after the date  
24 of the enactment of this Act, the Secretary of Veterans  
25 Affairs shall submit to the Committee on Veterans’ Affairs  
26 of the Senate and the Committee on Veterans’ Affairs of

1 the House of Representatives a report on the beneficiary  
2 travel program under section 111 of title 38, United  
3 States Code, as amended by subsection (a), including—

4 (1) the cost of the program;

5 (2) the number of veterans served by the pro-  
6 gram; and

7 (3) any other matters the Secretary considers  
8 appropriate.

9 (c) EFFECTIVE DATE.—The amendment made by  
10 this Act shall take effect on the first day of the first fiscal  
11 year that begins after the date of the enactment of this  
12 Act.
