**A BILL**

To amend the Omnibus Public Land Management Act of 2009 to make a technical correction to the water rights settlement for the Shoshone-Paiute Tribes of the Duck Valley Reservation, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Technical Correction  
3 to the Shoshone-Paiute Tribes of the Duck Valley Res-  
4 ervation Water Rights Settlement Act of 2023”.

5 **SEC. 2. AUTHORIZATION OF PAYMENT OF ADJUSTED IN-  
6 TEREST ON DEVELOPMENT FUND.**

7 Section 10807(b)(3) of the Omnibus Public Land  
8 Management Act of 2009 (Public Law 111–11; 123 Stat.  
9 1409) is amended—

10 (1) by striking “There is” and inserting the fol-  
11 lowing:

12 “(A) IN GENERAL.—There is”; and

13 (2) by adding at the end the following:

14 “(B) ~~ADJUSTED INTEREST PAYMENTS.—~~

15 “(i) ~~IN GENERAL.—~~There is author-  
16 ized to be appropriated to the Secretary  
17 for deposit into the Development Fund  
18 \$5,124,902.12.

19 “(ii) ~~COST INDEXING.—~~All amounts  
20 made available to carry out clause (i) shall,  
21 on deposit into the Development Fund, be  
22 adjusted to reflect changes since January  
23 25, 2016, in the Consumer Price Index for  
24 All Urban Consumers West Urban 50,000  
25 to 1,500,000 published by the Bureau of  
26 Labor Statistics.

1                   “(B) *ADJUSTED INTEREST PAYMENTS.*—  
2                   *There is authorized to be appropriated to the*  
3                   *Secretary for deposit into the Development Fund*  
4                   *\$5,124,902.12.*”.
