This bill appropriates (\$131,411,000), including \$6,680,900 from the General/Education Funds for FY 2020, plus \$5,539,611,700, including \$3,530,542,800 from the General/Education Funds for FY 2021. The appropriations support the operations of state and local education agencies, including expendable funds and accounts. This bill transfers another \$229,485,200 in FY 2021 from the Education Fund into other funds and accounts. Appropriations in this bill include weighted pupil unit and programmatic funding increases/decreases associated with estimated student enrollment growth impacts in fall 2020. This bill increases the number of WPUs by 9,459 to a total of 888,155 to support the 675,305 students projected to enroll in public schools this fall (an increase of 7,902 students). The total cost of these enrollment growth changes include \$50.6 million ongoing and \$4.7 million one-time.
