8	General Description:
9	This bill enacts provisions related to the hunting of waterfowl and other wildlife.

15	 prohibits big game baiting;
16	 prohibits the construction of permanent blinds or other structures used for hunting

19	waterfowl management area; and
20	 authorizes and instructs the Wildlife Board to make rules regarding the creation and
21	management of waterfowl management areas.

40	(1) A person may not use a computer or other device to remotely control the aiming
41	and discharge of a firearm or other weapon for hunting an animal.
42	(2) A person who violates Subsection (1) is guilty of a class A misdemeanor.
43	(3) (a) As used in this Subsection (3), "trail camera" means a device that is not held or
44	manually operated by a person and is used to capture images, video, or location data of wildlife
45	using heat or motion to trigger the device.

62	(b) "Baited area" means all land within a 50-yard radius of the site where bait is placed,
63	including the site where bait is placed.
64	(2) Unless authorized by a certificate of registration, it is unlawful to:
65	(a) bait big game;
66	(b) take big game in a baited area; or
67	(c) take big game that has been lured to or is traveling from a baited area.
68	(3) The division may only issue a certificate of registration to allow for the baiting of
69	big game if the division determines that baiting is necessary to alleviate substantial big game
70	depredation on cultivated crops or to facilitate the removal of deer causing property damage
