85 credits for certain persons in recycling market development zones, are repealed for taxable  
86 years beginning on or after January 1, 2021.

87 (c) A person may not claim a tax credit under Section 59-7-610 or 59-10-1007:

88 (i) for the purchase price of machinery or equipment described in Section 59-7-610 or  
89 59-10-1007, if the machinery or equipment is purchased on or after January 1, 2021; or

90 (ii) for an expenditure described in Subsection 59-7-610(1)(b) or 59-10-1007(1)(b), if  
91 the expenditure is made on or after January 1, 2021.

92 (d) Notwithstanding Subsections (18)(b) and (c), a person may carry forward a tax  
93 credit in accordance with Section 59-7-610 or 59-10-1007 if:

94 (i) the person is entitled to a tax credit under Section 59-7-610 or 59-10-1007; and

95 (ii) (A) for the purchase price of machinery or equipment described in Section  
96 59-7-610 or 59-10-1007, the machinery or equipment is purchased on or before December 31,

98 (B) for an expenditure described in Subsection 59-7-610(1)(b) or 59-10-1007(1)(b), the  
99 expenditure is made on or before December 31, 2020.

106 accordance with Section 59-9-107 if:

107 (i) the person is entitled to a tax credit under Section 59-9-107 on or before December  
108 31, 2020; and

109 (ii) the qualified equity investment that is the basis of the tax credit is certified under  
110 Section 63N-2-603 on or before December 31, 2023.
