AMENDMENT IN THE NATURE OF A SUBSTITUTE

(Proposed by the Senate Committee on Education and Health

on _____)

(Patron Prior to Substitute--Senator Pillion)

A BILL to amend and reenact § 32.1-330 of the Code of Virginia, relating to long-term services and support screening; PACE programs; emergency.

Be it enacted by the General Assembly of Virginia:

1. That § 32.1-330 of the Code of Virginia is amended and reenacted as follows:

§ 32.1-330. Long-term services and supports screening required.

A. As used in this section, "acute care hospital" includes an acute care hospital, a rehabilitation hospital, a rehabilitation unit in an acute care hospital, or a psychiatric unit in an acute care hospital.

B. Every individual who applies for or requests community or institutional long-term services and supports as defined in the state plan for medical assistance services may choose to receive services in a community or institutional setting. Every individual who applies for or requests community or institutional long-term services and supports shall be afforded the opportunity to choose the setting and provider of long-term services and supports.

C. Every individual who applies for or requests community or institutional long-term services and supports shall be screened prior to admission to such community or institutional long-term services and supports to determine his need for long-term services and supports, including nursing facility services as defined in the state plan for medical assistance services. The type of long-term services and supports screening performed shall not limit the long-term services and supports settings or providers for which the individual is eligible.

D. ~~If~~ Except as otherwise provided in this subsection, if an individual who applies for or requests long-term services and supports as defined in the state plan for medical assistance services is residing in a community setting at the time of such application or request, the screening for long-term services and

27 supports required pursuant to subsection C shall be completed by a long-term services and supports
28 screening team that includes a nurse, social worker or other assessor designated by the Department who
29 is an employee of the Department of Health or the local department of social services, and a physician
30 who is employed or engaged by the Department of Health. To the extent such screening team determines
31 it is unable to complete the long-term services and supports screening within 30 days or the individual has
32 requested enrollment in a program of all-inclusive care for the elderly (PACE) as defined in § 32.1-330.3,
33 such screening team shall confer as to which entity can most expeditiously conduct the long-term services
34 and supports screening. Qualified staff of the PACE program shall be organized to conduct such screening
35 if it is determined that it is the most expeditious option.

36 E. If an individual who applies for or requests long-term services and supports as defined in the
37 state plan for medical assistance services is receiving inpatient services in an acute care hospital at the
38 time of such application or request and will begin receiving long-term services and supports as defined in
39 the state plan for medical assistance services pursuant to a discharge order from an acute care hospital, the
40 screening for long-term services and supports required pursuant to subsection C shall be completed by the
41 acute care hospital in accordance with the screening requirements established by the Department.

42 F. If an individual who applies for or requests long-term services and supports as defined in the
43 state plan for medical assistance services is receiving skilled nursing services that are not covered by the
44 Commonwealth's program of medical assistance services in an institutional setting following discharge
45 from an acute care hospital, the Department shall require qualified staff of the skilled nursing institution
46 to conduct the long-term services and supports screening in accordance with the requirements established
47 by the Department, with the results certified by a physician prior to the initiation of long-term services
48 and supports under the state plan for medical assistance services.

49 G. If an individual is admitted to a skilled nursing facility for skilled nursing services and such
50 individual was not screened but is subsequently determined to have been required to be screened prior to
51 admission to the skilled nursing facility, then the qualified staff designated in subsection F may conduct a
52 screening after admission. Coverage of institutional long-term services and supports under this subsection
53 by the Commonwealth's program of medical assistance services indicated by the screening shall not begin

54 until six months after the initial admission to the skilled nursing facility. During this six-month period, the
55 nursing home in which the individual resides shall be responsible for all costs indicated for institutional
56 long-term services and supports that would otherwise have been covered by the Commonwealth's program
57 of medical assistance services, without accessing patient funds. Six months after the date of admission to
58 the skilled nursing facility, and as indicated through the eligibility determination, the Commonwealth's
59 program of medical assistance services shall assume coverage of such services. To the extent that
60 sufficient evidence is provided to indicate that the admission without screening was of no fault of the
61 skilled nursing facility, the Department shall begin coverage of institutional long-term services and
62 supports under this subsection by the Commonwealth's program of medical assistance services
63 immediately upon the completion of the functional screening indicating nursing facility level of care
64 pending the financial eligibility determination.

65 H. If an individual seeks enrollment in a program of all-inclusive care for the elderly (PACE) as
66 defined in § 32.1-330.3, qualified staff of the PACE program may conduct the long-term services and
67 supports screening in accordance with the requirements established by the Department, with the results
68 certified by the PACE program's physician prior to the initiation of long-term services and supports under
69 the state plan for medical assistance services. If a PACE program is unable to complete the long-term
70 services and supports screening of an individual, the screening teams described in subsection D or the
71 acute care hospital described in subsection E shall conduct the screening.

72 I. In any jurisdiction in which a long-term services and supports screening team described in
73 subsection D or the acute care hospital described in subsection E has failed or is unable to perform the
74 long-term services and supports screenings required by subsection D or E within 30 days of receipt of the
75 individual's application or request for long-term services and supports under the state plan, the Department
76 shall enter into contracts with other public or private entities to conduct such long-term services and
77 supports screenings in addition to or in lieu of the long-term services and supports screening teams
78 described in ~~subsections~~ subsection D and or the acute care hospitals described in subsection E. This
79 subsection shall not apply to the specific circumstance outlined in subsection D where the qualified staff
80 of a PACE program agree to conduct such screening.
