10	Statement of purpose of bill as introduced: This bill proposes to require health
11	insurance plans and the Dr. Dynasaur program to cover pasteurized donated
12	human breast milk for infants under 12 months of age under certain
13	circumstances.

15	It is hereby enacted by the General Assembly of the State of Vermont:
16	Sec. 1. 8 V.S.A. § 4093 is added to read:
17	<u>§ 4093. DONATED HUMAN BREAST MILK</u>
18	(a) As used in this section, "health insurance plan" means any individual or
19	group health insurance policy, any hospital or medical service corporation or
20	health maintenance organization subscriber contract, or any other health

1	benefit plan offered, issued, or renewed for any person in this State by a health
2	insurer as defined in 18 V.S.A. § 9402. The term does not include benefit
3	plans providing coverage for a specific disease or other limited benefit
4	coverage.
5	(b) A health insurance plan, including a plan providing coverage for a
6	newborn during the period required by section 4092 of this chapter, shall
7	provide coverage for pasteurized donated human breast milk, including human
8	milk fortifiers if so indicated by the prescriber, for an insured who is an infant
9	under 12 months of age if all of the following conditions are met:
10	(1) the milk is prescribed for the infant by a licensed health care
11	professional;
12	(2) the milk and human milk fortifiers are obtained from a human milk
13	bank or dispensing site that is certified by the Human Milk Banking
14	Association of North America or is licensed by the Vermont Department of
15	Health;
16	(3) the infant's parent or guardian is not medically or physically able to
17	produce human milk or to produce human milk in sufficient quantities to meet
18	the infant's needs, or the parent's or guardian's human milk is contraindicated;

20	(4) the milk has been determined to be medically necessary for the

15	Program who is an infant under 12 months of age if all of the following
16	conditions are met:
