1 AN ACT Relating to additional temporary duties for the wildland
2 fire advisory committee; and amending 2018 c 227 s 1 (uncodified).

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 **Sec. 1.** 2018 c 227 s 1 (uncodified) is amended to read as
5 follows:

6 (1) Subject to amounts appropriated for this specific purpose,
7 the commissioner of public lands must direct the wildland fire
8 advisory committee established in RCW 76.04.179 to review, analyze,
9 and make recommendations on the following issues related to wild fire
10 prevention, response, and suppression activities within our state:

11 (a) The committee, with the assistance of department of natural
12 resources' personnel, must approximately quantify the areas in the
13 state that are not contained within an established fire district nor
14 subject to a planned fire response and make recommendations as to how
15 these areas could be protected as well as a source of funding for any
16 recommended activities. In doing so, the committee must, in time for
17 inclusion in the December 31, 2018, status report: Review the
18 relevant recommendations contained in the joint legislative audit and
19 review committee's 2017 final report on fees assessed for forest fire
20 protection; analyze and develop recommendations on potential
21 administrative and legislative actions including, for example, the

1 process proposed in chapter . . . (Substitute Senate Bill No. 6575),
2 Laws of 2018; and consult with any relevant stakeholders, as deemed
3 necessary by the committee, that are not represented on the
4 committee.

5 (b) The committee must examine the value of community programs
6 that educate homeowners and engage in preventive projects within wild
7 fire risk communities, such as firewise, and make recommendations on
8 whether these programs should be advanced, and if so, how, including
9 potential sources of ongoing funding for the programs.

10 (c) The committee must also develop plans to help protect non-
11 English speaking residents during wildfire emergencies. The committee
12 may enlist the assistance from the state ethnic and diversity
13 commissions or any other organizations who have expertise in public
14 outreach to non-English speaking people.

15 (2) The department of natural resources must provide to the
16 appropriate committees of the legislature a status report of the
17 committee's efforts by December 31, 2018, and issue a report with the
18 committee's recommendations by November 15, 2019.

19 (3) In addition to the topics described in subsection (1) of this
20 section, as part of the final report as required by subsection (2) of
21 this section, and subject to the availability of amounts appropriated
22 for this specific purpose, the wildland fire advisory committee must
23 review, analyze, and make recommendations on the following issues
24 related to the establishment of rangeland fire protection
25 associations and other fire protection methods within our state to
26 address unprotected and underprotected lands.

27 (a) The committee, with the assistance of department of natural
28 resources' personnel, must map areas of the state east of the crest
29 of the Cascade mountains that are not within an established fire
30 protection district, nor subject to a planned wildland fire response.

31 (b) The committee, through consultation with landowners, local
32 fire protection districts, wildfire protection agencies, and other
33 interested parties, must identify and make recommendations as to
34 which methods of protection may be best suited for these areas when
35 considering values at risk, including wildlife habitat, available
36 response resources, and geography in the area. Methods of protection
37 may include, but are not limited to, annexation by adjacent fire
38 protection districts, creation of new fire protection districts, and
39 the broadening of the jurisdiction of the department of natural
40 resources.

1 (c) The committee must make recommendations on the appropriate
2 level of training and the personal protective equipment standards for
3 rangeland fire protection associations.

4 (d) The committee must make an estimate of the costs to establish
5 and maintain rangeland fire protection associations. In addition, the
6 committee must make recommendations for appropriate fees to support
7 the various identified methods of protection, including increasing
8 fire protection district levies and fees collected by the department
9 of natural resources.

10 (4) This section expires December 31, 2019.
