- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 **Sec. 1.** RCW 77.12.037 and 2000 c 107 s 4 are each amended to 6 read as follows:
- 7 (1) The commission may acquire by gift, easement, purchase, 8 lease, or condemnation lands, buildings, water rights, rights-of-way,
- 9 or other necessary property, and construct and maintain necessary
- 10 facilities for purposes consistent with this title. The commission 11 may authorize the director to acquire property under this section,
- 11 may authorize the director to acquire property under this section,
- 12 but the power of condemnation may only be exercised by the director
- 13 when an appropriation has been made by the legislature for the
- 14 acquisition of a specific property, except to clear title and acquire
- 15 access rights-of-way.
- 16 (2) The department has the authority to manage acquired lands
