1       AN ACT Relating to providing funding for the Washington state  
2 library-archives building and operations of library and archives  
3 facilities; amending RCW 36.18.010, 36.22.175, 36.22.175, 43.07.128,  
4 43.07.129, and 43.07.370; reenacting and amending RCW 43.79A.040;  
5 adding new sections to chapter 43.07 RCW; creating a new section;  
6 providing an effective date; and providing an expiration date.

7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

8       NEW SECTION.   **Sec. 1.** (1) The legislature finds that the current  
9 facilities housing the Washington state archives, Washington state  
10 library, Washington state corporations and charities office, and the  
11 state elections office is in need of modernization and update. This  
12 is due to these vital programs being housed in obsolete and crowded  
13 facilities that do not meet modern standards for the functions  
14 performed in each.

15       (2) It is the intent of the secretary of state and the  
16 legislature to preserve and protect the state's vital records and  
17 collections, provide convenient service to the public, be excellent  
18 stewards of state funds, and house staff and collections in a state  
19 of the art, energy efficient building owned and operated by the  
20 office of the secretary of state. This will be accomplished by  
21 constructing a new building funded by a financing contract entered

1 into by the secretary of state pursuant to chapter 39.94 RCW. The  
2 principal and interest requirements of the financing contract will be  
3 serviced by existing rents, existing fees, and a new fee on documents  
4 recorded at county recording offices.

5 (3) This building, to be known as the library-archives building,  
6 will replace the existing state archives, the existing leased library  
7 location, the existing leased elections office, and the corporations  
8 and charities building on Capitol Way in addition to consolidating  
9 other archival structures. The consolidation of facilities will  
10 create efficiency under RCW 43.82.010(6) and convenience for  
11 customers with the eventual goal of housing all functions of the  
12 various divisions of the office of the secretary of state.

13 NEW SECTION. **Sec. 2.** A new section is added to chapter 43.07  
14 RCW to read as follows:

15 The secretary of state's office shall own and operate the  
16 library-archives building. The secretary of state's office is  
17 authorized to enter into a long-term land lease from the port of  
18 Olympia for a period of up to seventy-five years. To comply with the  
19 provisions of this section, this project is exempt from the  
20 provisions of RCW 43.82.010.

21 **Sec. 3.** RCW 36.18.010 and 2015 3rd sp.s. c 28 s 1 are each  
22 amended to read as follows:

23 County auditors or recording officers shall collect the following  
24 fees for their official services:

25 (1) For recording instruments, for the first page eight and one-  
26 half by fourteen inches or less, five dollars; for each additional  
27 page eight and one-half by fourteen inches or less, one dollar. The  
28 fee for recording multiple transactions contained in one instrument  
29 will be calculated for each transaction requiring separate indexing  
30 as required under RCW 65.04.050 as follows: The fee for each title or  
31 transaction is the same fee as the first page of any additional  
32 recorded document; the fee for additional pages is the same fee as  
33 for any additional pages for any recorded document; the fee for the  
34 additional pages may be collected only once and may not be collected  
35 for each title or transaction;

36 (2) For preparing and certifying copies, for the first page eight  
37 and one-half by fourteen inches or less, three dollars; for each

1 additional page eight and one-half by fourteen inches or less, one  
2 dollar;

3 (3) For preparing noncertified copies, for each page eight and  
4 one-half by fourteen inches or less, one dollar;

5 (4) For administering an oath or taking an affidavit, with or  
6 without seal, two dollars;

7 (5) For issuing a marriage license, eight dollars, (this fee  
8 includes taking necessary affidavits, filing returns, indexing, and  
9 transmittal of a record of the marriage to the state registrar of  
10 vital statistics) plus an additional five dollar fee for use and  
11 support of the prevention of child abuse and neglect activities to be  
12 transmitted monthly to the state treasurer and deposited in the state  
13 general fund plus an additional ten dollar fee to be transmitted  
14 monthly to the state treasurer and deposited in the state general  
15 fund. The legislature intends to appropriate an amount at least equal  
16 to the revenue generated by this fee for the purposes of the  
17 displaced homemaker act, chapter 28B.04 RCW;

18 (6) For searching records per hour, eight dollars;

19 (7) For recording plats, fifty cents for each lot except cemetery  
20 plats for which the charge shall be twenty-five cents per lot; also  
21 one dollar for each acknowledgment, dedication, and description:  
22 PROVIDED, That there shall be a minimum fee of twenty-five dollars  
23 per plat;

24 (8) For recording of miscellaneous records not listed above, for  
25 the first page eight and one-half by fourteen inches or less, five  
26 dollars; for each additional page eight and one-half by fourteen  
27 inches or less, one dollar;

28 (9) For modernization and improvement of the recording and  
29 indexing system, a surcharge as provided in RCW 36.22.170;

30 (10) For recording an emergency nonstandard document as provided  
31 in RCW 65.04.047, fifty dollars, in addition to all other applicable  
32 recording fees;

33 (11) For recording instruments, a three dollar surcharge to be  
34 deposited into the Washington state (~~heritage center~~) library  
35 operations account created in RCW 43.07.129;

36 (12) For recording instruments, a two dollar surcharge to be  
37 deposited into the Washington state library-archives building account  
38 created in section 9 of this act until the financing contract entered  
39 into by the secretary of state for the Washington state library-  
40 archives building is paid in full;

1        (13) For recording instruments, a surcharge as provided in RCW  
2 36.22.178; and

3        (~~(13)~~) (14) For recording instruments, except for documents  
4 recording a birth, marriage, divorce, or death or any documents  
5 otherwise exempted from a recording fee under state law, a surcharge  
6 as provided in RCW 36.22.179.

7        **Sec. 4.** RCW 36.22.175 and 2017 c 303 s 7 are each amended to  
8 read as follows:

9        (1)(a) In addition to any other charge authorized by law, the  
10 county auditor shall charge a surcharge of one dollar per instrument  
11 for each document recorded. Revenue generated through this surcharge  
12 shall be transmitted monthly to the state treasurer for deposit in  
13 the local government archives account under RCW 40.14.024. These  
14 funds shall be used solely for providing records schedule compliance,  
15 security microfilm inspection and storage, archival preservation,  
16 cataloging, and indexing for local government records and digital  
17 data and access to those records and data through the regional branch  
18 archives of the division of archives and records management.

19        (b) The division of archives and records management within the  
20 office of the secretary of state shall provide records management  
21 training for local governments and shall establish a competitive  
22 grant program to solicit and prioritize project proposals from local  
23 governments for potential funding to be paid for by funds from the  
24 auditor surcharge and tax warrant surcharge revenues. Application for  
25 specific projects may be made by local government agencies only. The  
26 state archivist in consultation with the advisory committee  
27 established under RCW 40.14.027 shall adopt rules governing project  
28 eligibility, evaluation, awarding of grants, and other criteria  
29 including requirements for records management training for grant  
30 recipients.

31        (2) The advisory committee established under RCW 40.14.027 shall  
32 review grant proposals and establish a prioritized list of projects  
33 to be considered for funding by January 1st of each even-numbered  
34 year, beginning in 2002. The evaluation of proposals and development  
35 of the prioritized list must be developed through open public  
36 meetings. Funding for projects shall be granted according to the  
37 ranking of each application on the prioritized list and projects will  
38 be funded only to the extent that funds are available. A grant award

1 may have an effective date other than the date the project is placed  
2 on the prioritized list.

22 the local government archives account under RCW 40.14.024. These

22 under Title 23B RCW;

23 (b) Certificates of formation for domestic limited liability  
24 companies or registrations of foreign limited liability companies  
25 under chapter 25.15 RCW;

26 (c) Registrations of foreign and domestic partnerships and  
27 limited liability partnerships under chapter 25.05 RCW;

28 (d) Certificates of limited partnership(~~+~~) s and  
29 registration(~~+~~) s of foreign limited partnerships under chapter  
30 25.10 RCW; and

31 (e) Registrations of trademarks under chapter 19.77 RCW.

32 (2) Moneys received under subsection (1) of this section must be

36 amended to read as follows:

2 the account. Expenditures from the account may be made only for the  
3 following purposes:

26 **Sec. 8.** RCW 43.07.370 and 2009 c 71 s 1 are each amended to read  
27 as follows:

28 (1) The secretary of state may solicit and accept gifts, grants,  
29 conveyances, bequests, and devises of real or personal property, or  
30 both, in trust or otherwise, and sell, lease, exchange, invest, or  
31 expend these donations or the proceeds, rents, profits, and income  
32 from the donations except as limited by the donor's terms.

33 (2) Moneys received under this section may be used only for the  
34 following purposes:

35 (a) Conducting the Washington state legacy project;

36 (b) Archival activities;

37 (c) Washington state library activities;

38 (d) Development, construction, and operation of the Washington  
39 state ~~((heritage center))~~ library-archives building; and

1 (e) Donation of Washington state flags.

2 (3)(a) Moneys received under subsection (2)(a) through (c) of  
3 this section must be deposited in the Washington state legacy  
4 project, state library, and archives account established in RCW

6 (b) Moneys received under subsection (2)(d) of this section must  
7 be deposited in the Washington state (~~heritage center~~) library-  
8 archives building account created in (~~RCW 43.07.129~~) section 9 of  
9 this act.

10 (c) Moneys received under subsection (2)(e) of this section must  
11 be deposited in the Washington state flag account created in RCW  
12 43.07.388.

13 (4) The secretary of state shall adopt rules to govern and  
14 protect the receipt and expenditure of the proceeds.

15 NEW SECTION. **Sec. 9.** A new section is added to chapter 43.07  
16 RCW to read as follows:

17 The Washington state library-archives building account is created  
18 in the custody of the state treasurer. All moneys received under RCW  
19 36.18.010(12), 36.22.175(3), and 43.07.370(3) must be deposited in  
20 the account. Expenditures from the account may be made only for the  
21 purposes of payment of the financing contract entered into by the  
22 secretary of state for the Washington state library-archives  
23 building. Only the secretary of state or the secretary of state's  
24 designee may authorize expenditures from the account. An  
25 appropriation is not required for expenditures, but the account is  
26 subject to allotment procedures under chapter 43.88 RCW.

27 **Sec. 10.** RCW 43.79A.040 and 2018 c 260 s 28, 2018 c 258 s 4, and  
28 2018 c 127 s 6 are each reenacted and amended to read as follows:

29 (1) Money in the treasurer's trust fund may be deposited,  
30 invested, and reinvested by the state treasurer in accordance with  
31 RCW 43.84.080 in the same manner and to the same extent as if the  
32 money were in the state treasury, and may be commingled with moneys  
33 in the state treasury for cash management and cash balance purposes.

34 (2) All income received from investment of the treasurer's trust  
35 fund must be set aside in an account in the treasury trust fund to be  
36 known as the investment income account.

37 (3) The investment income account may be utilized for the payment  
38 of purchased banking services on behalf of treasurer's trust funds

1 including, but not limited to, depository, safekeeping, and  
2 disbursement functions for the state treasurer or affected state  
3 agencies. The investment income account is subject in all respects to  
4 chapter 43.88 RCW, but no appropriation is required for payments to  
5 financial institutions. Payments must occur prior to distribution of  
6 earnings set forth in subsection (4) of this section.

7 (4)(a) Monthly, the state treasurer must distribute the earnings  
8 credited to the investment income account to the state general fund  
9 except under (b), (c), and (d) of this subsection.

10 (b) The following accounts and funds must receive their  
11 proportionate share of earnings based upon each account's or fund's  
12 average daily balance for the period: The 24/7 sobriety account, the  
13 Washington promise scholarship account, the Gina Grant Bull memorial  
14 legislative page scholarship account, the Washington advanced college  
15 tuition payment program account, the Washington college savings  
16 program account, the accessible communities account, the Washington  
17 achieving a better life experience program account, the community and  
18 technical college innovation account, the agricultural local fund,  
19 the American Indian scholarship endowment fund, the foster care  
20 scholarship endowment fund, the foster care endowed scholarship trust  
21 fund, the contract harvesting revolving account, the Washington state  
22 combined fund drive account, the commemorative works account, the  
23 county enhanced 911 excise tax account, the toll collection account,  
24 the developmental disabilities endowment trust fund, the energy  
25 account, the fair fund, the family and medical leave insurance  
26 account, the fish and wildlife federal lands revolving account, the  
27 natural resources federal lands revolving account, the food animal  
28 veterinarian conditional scholarship account, the forest health  
29 revolving account, the fruit and vegetable inspection account, the  
30 future teachers conditional scholarship account, the game farm  
31 alternative account, the GET ready for math and science scholarship  
32 account, the Washington global health technologies and product  
33 development account, the grain inspection revolving fund, the  
34 Washington history day account, the industrial insurance rainy day  
35 fund, the juvenile accountability incentive account, the law  
36 enforcement officers' and firefighters' plan 2 expense fund, the  
37 local tourism promotion account, the low-income home rehabilitation  
38 revolving loan program account, the multiagency permitting team  
39 account, the northeast Washington wolf-livestock management account,  
40 the pilotage account, the produce railcar pool account, the regional

1 transportation investment district account, the rural rehabilitation  
2 account, the Washington sexual assault kit account, the stadium and  
3 exhibition center account, the youth athletic facility account, the  
4 self-insurance revolving fund, the children's trust fund, the  
5 Washington horse racing commission Washington bred owners' bonus fund  
6 and breeder awards account, the Washington horse racing commission  
7 class C purse fund account, the individual development account  
8 program account, the Washington horse racing commission operating  
9 account, the life sciences discovery fund, the Washington state  
10 (~~heritage center~~) library-archives building account, the reduced  
11 cigarette ignition propensity account, the center for childhood

19 (c) The following accounts and funds must receive eighty percent  
20 of their proportionate share of earnings based upon each account's or  
21 fund's average daily balance for the period: The advanced right-of-  
22 way revolving fund, the advanced environmental mitigation revolving  
23 account, the federal narcotics asset forfeitures account, the high  
24 occupancy vehicle account, the local rail service assistance account,  
25 and the miscellaneous transportation programs account.

26 (d) Any state agency that has independent authority over accounts  
27 or funds not statutorily required to be held in the custody of the  
28 state treasurer that deposits funds into a fund or account in the  
29 custody of the state treasurer pursuant to an agreement with the  
30 office of the state treasurer shall receive its proportionate share  
31 of earnings based upon each account's or fund's average daily balance  
32 for the period.

33 (5) In conformance with Article II, section 37 of the state  
34 Constitution, no trust accounts or funds shall be allocated earnings
