- AN ACT Relating to providing funding for the hunter education training program operated by the department of fish and wildlife through the issuance of national rifle association special license plates; amending RCW 46.68.425 and 77.15.425; reenacting and amending RCW 46.18.200 and 46.17.220; adding a new section to chapter 46.04 RCW; and providing an effective date.
- 7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 8 **Sec. 1.** RCW 46.18.200 and 2014 c 77 s 1 and 2014 c 6 s 1 are 9 each reenacted and amended to read as follows:
- 10 (1) Special license plate series reviewed and approved by the 11 department:
- 12 (a) May be issued in lieu of standard issue or personalized 13 license plates for vehicles required to display one and two license 14 plates unless otherwise specified;
- 15 (b) Must be issued under terms and conditions established by the department;
- 17 (c) Must not be issued for vehicles registered under chapter 18 46.87 RCW; and
- 19 (d) Must display a symbol or artwork approved by the department.
- 20 (2) The department approves and shall issue the following special license plates:

- (3) Applicants for initial and renewal professional firefighters and paramedics special license plates must show proof <u>of</u> eligibility by providing a certificate of current membership from the Washington state council of firefighters.
- (4) Applicants for initial volunteer firefighters special license plates must (a) have been a volunteer firefighter for at least ten years or be a volunteer firefighter for one or more years and (b) have documentation of service from the district of the appropriate the volunteer firefighter leaves fire service. Ιf firefighting service before ten years of service have been completed, volunteer firefighter shall surrender the license plates to the department on the registration renewal date. If the volunteer firefighter stays in service for at least ten years and then leaves, the license plate may be retained by the former volunteer firefighter and as long as the license plate is retained for use the person will continue to pay the future registration renewals. A qualifying volunteer firefighter may have no more than one set of license plates per vehicle, and a maximum of two sets per applicant, for their personal vehicles. If the volunteer firefighter is convicted of a violation of RCW 46.61.502 or a felony, the license plates must be surrendered upon conviction.

"National rifle association license plates" means special license plates issued under RCW 46.18.200 that display the "National Rifle Association" logo.

 - (1) In addition to all fees and taxes required to be paid upon application for a vehicle registration in chapter 46.16A RCW, the holder of a special license plate shall pay the appropriate special license plate fee as listed in this section.

(2) After deducting administration and collection expenses for the sale of baseball stadium license plates, the remaining proceeds must be distributed to a county for the purpose of paying the principal and interest payments on bonds issued by the county to construct a baseball stadium, as defined in RCW 82.14.0485, including reasonably necessary preconstruction costs, while the taxes are being collected under RCW 82.14.360. After this date, the state treasurer shall credit the funds to the state general fund.

- 9 (c) Remit the remaining proceeds to the custody of the state 10 treasurer with a proper identifying detailed report.

Sec. 5. RCW 77.15.425 and 2016 c 2 s 6 (Initiative Measure No. 1401) are each amended to read as follows:

The fish and wildlife enforcement reward account is created in the custody of the state treasurer. Deposits to the account include: Receipts from fish and shellfish overages as a result of a department enforcement action; fees for hunter education deferral applications; fees for master hunter applications and master hunter certification renewals; fees for national rifle association license plates as provided in RCW 46.68.425; all receipts from criminal wildlife penalty assessments under this chapter; all receipts of court-ordered restitution or donations associated with any fish, shellfish, wildlife enforcement and proceeds from forfeitures action; evidence pursuant to RCW 77.15.070 and 77.15.100. The department may accept money or personal property from persons under conditions requiring the property or money to be used consistent with the intent expenditures from the fish and wildlife enforcement account. Expenditures from the only account may used

1 investigation and prosecution of fish and wildlife offenses, to provide rewards to persons informing the department about violations 2 of this title and rules adopted under this title, to offset 3 department-approved costs incurred to administer the hunter education 4 deferral program and the master hunter permit program, for the 5 6 enhanced support of firearm safety and education as part of the hunter education training program under RCW 77.32.155, and for other 7 valid enforcement uses as determined by the commission. Only the 8 director or the director's designee may authorize expenditures from 9 the account. The account is subject to allotment procedures under 10 chapter 43.88 RCW, but an appropriation is not required for 11 12 expenditures.

13 <u>NEW SECTION.</u> **Sec. 6.** This act takes effect January 1, 2017.
