AN ACT Relating to limiting state and local taxes, fees, and other charges relating to vehicles; amending RCW 46.17.355 and 46.17.323; reenacting and amending RCW 46.17.350; adding a new section to chapter 46.17 RCW; creating new sections; repealing RCW 46.17.365 and 46.68.415; and declaring an emergency.

## LIMITING ANNUAL MOTOR VEHICLE LICENSE FEES TO \$30

9 <u>NEW SECTION.</u> Sec. 1. A new section is added to chapter 46.17 10 RCW to read as follows:

(1) State and local motor vehicle license fees may not exceed \$30 per year for motor vehicles, regardless of year, value, make, or model.

14 (2) For the purposes of this section, "state and local motor 15 vehicle license fees" means the general license tab fees paid 16 annually for licensing motor vehicles, including but not limited to 17 cars, sport utility vehicles, light trucks under RCW 46.17.355, 18 motorcycles, and motor homes, and do not include charges approved by 19 voters after the effective date of this section. This annual fee must

1 be paid and collected annually and is due at the time of initial and 2 renewal vehicle registration.

3 Sec. 2. RCW 46.17.350 and 2019 c 44 s 4 are each reenacted and 4 amended to read as follows:

5 (1) Before accepting an application for a vehicle registration, 6 the department, county auditor or other agent, or subagent appointed 7 by the director shall require the applicant, unless specifically 8 exempt, to pay the following vehicle license fee by vehicle type:

7 (3) If the resultant gross weight is not listed in the table 8 provided in subsection (1) of this section, it must be increased to 9 the next higher weight.

10 (4) The license fees provided in subsection (1) of this section 11 and the freight project fee provided in subsection (((-6))) (7) of 12 this section are in addition to the filing fee required under RCW 13 46.17.005 and any other fee or tax required by law.

14 (5) <u>The license fees provided in subsection (1) of this section</u>
 15 <u>for light trucks weighing 10,000 pounds or less are limited to \$30.</u>

16 (6) The license fee based on declared gross weight as provided in 17 subsection (1) of this section must be distributed under RCW 18 46.68.035.

19 ((-(6))) (7) For vehicle registrations that are due or become due 20 on or after July 1, 2016, in addition to the license fee based on declared gross weight as provided in subsection (1) of this section, 21 22 the department, county auditor or other agent, or subagent appointed 23 by the director must require an applicant with a vehicle with a 24 declared gross weight of more than 10,000 pounds, unless specifically exempt, to pay a freight project fee equal to ((fifteen)) 15 percent 25 26 of the license fee provided in subsection (1) of this section, 27 rounded to the nearest whole dollar, which must be distributed under 28 RCW 46.68.035.

29 (((-7))) (8) For vehicle registrations that are due or become due 30 on or after July 1, 2022, in addition to the license fee based on 31 declared gross weight as provided in subsection (1) of this section, the department, county auditor or other agent, or subagent appointed 32 33 by the director must require an applicant with a vehicle with a 34 declared gross weight of less than or equal to 12,000 pounds, unless 35 specifically exempt, to pay an additional weight fee of ((<del>ten</del> dollars)) \$10, which must be distributed under RCW 46.68.035. 36

37 Sec. 4. RCW 46.17.323 and 2015 3rd sp.s. c 44 s 203 are each 38 amended to read as follows:

p. 7

1 (1) Before accepting an application for an annual vehicle registration renewal for a vehicle that both (a) uses at least one 2 method of propulsion that is capable of being reenergized by an 3 external source of electricity and (b) is capable of traveling at 4 least ((thirty)) 30 miles using only battery power, the department, 5 6 county auditor or other agent, or subagent appointed by the director 7 must require the applicant to pay a ((one hundred dollar fee in addition to any other fees and taxes required by law)) \$30 fee. The 8 ((one hundred dollar)) \$30 fee is due only at the time of annual 9 10 registration renewal.

(2) This section only applies to a vehicle that is designed to have the capability to drive at a speed of more than ((thirty-five)) <u>35</u> miles per hour.

14 (3) ((<del>(a) The fee under this section is imposed to provide funds</del> 15 to mitigate the impact of vehicles on state roads and highways and 16 for the purpose of evaluating the feasibility of transitioning from a 17 revenue collection system based on fuel taxes to a road user assessment system, and is separate and distinct from other vehicle 18 license fees. Proceeds from the fee must be used for highway 19 purposes, and must be deposited in the motor vehicle fund created in 20 21 RCW 46.68.070, subject to (b) of this subsection.

(b)) If in any year the amount of proceeds from the fee collected under this section exceeds ((one million dollars)) <u>\$1,000,000</u>, the excess amount over ((one million dollars)) <u>\$1,000,000</u> must be deposited as follows:

26 ((<del>(i)</del>)) <u>(a)</u> Seventy percent to the motor vehicle fund created in 27 RCW 46.68.070;

28 ((<del>(ii)</del>)) <u>(b)</u> Fifteen percent to the transportation improvement 29 account created in RCW 47.26.084; and

30 ((((iii))) (c) Fifteen percent to the rural arterial trust account 31 created in RCW 36.79.020.

32 ((((4) (a) In addition to the fee established in subsection (1) of 33 this section, before accepting an application for an annual vehicle 34 registration renewal for a vehicle that both (i) uses at least one method of propulsion that is capable of being reenergized by an 35 external source of electricity and (ii) is capable of traveling at 36 37 least thirty miles using only battery power, the department, county 38 auditor or other agent, or subagent appointed by the director must 39 require the applicant to pay a fifty dollar fee.

- 1 (b) The fee required under (a) of this subsection must be 2 distributed as follows:
- 3 (i) The first one million dollars raised by the fee must be 4 deposited into the multimodal transportation account created in RCW 5 47.66.070; and
- 6 (ii) Any remaining amounts must be deposited into the motor 7 vehicle fund created in RCW 46.68.070.

8 (5) This section applies to annual vehicle registration renewals 9 until the effective date of enacted legislation that imposes a 10 vehicle miles traveled fee or tax.))

11 <u>NEW SECTION.</u> Sec. 5. The following acts or parts of acts are 12 each repealed:

(1) RCW 46.17.365 (Motor vehicle weight fee—Motor home vehicle weight fee) and 2015 3rd sp.s. c 44 s 202 & 2010 c 161 s 533; and (2) RCW 46.68.415 (Motor vehicle weight fee, motor home vehicle weight fee—Disposition) and 2010 c 161 s 813.

17 <u>NEW SECTION.</u> Sec. 6. CONSTRUCTION CLAUSE. The provisions of 18 this act are to be liberally construed to effectuate the intent, 19 policies, and purposes of this act.

20 <u>NEW SECTION.</u> Sec. 7. SEVERABILITY CLAUSE. If any provision of 21 this act or its application to any person or circumstance is held 22 invalid, the remainder of the act or the application of the provision 23 to other persons or circumstances is not affected.

24 <u>NEW SECTION.</u> Sec. 8. SHORT TITLE. This act may be known and 25 cited as the bring back our \$30 car tabs act.

26 <u>NEW SECTION.</u> Sec. 9. This act is necessary for the immediate 27 preservation of the public peace, health, or safety, or support of 28 the state government and its existing public institutions, and takes 29 effect immediately.
