## SENATE BILL 5183

1 AN ACT Relating to eligibility for relocation assistance for 2 tenants of closed or converted mobile home parks; amending RCW 3 59.21.005, 59.21.021, 59.21.025, and 59.21.050; and reenacting and 4 amending RCW 59.21.010.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6 Sec. 1. RCW 59.21.005 and 1995 c 122 s 2 are each amended to 7 read as follows:

8 The legislature recognizes that it is quite costly ((to move a mobile home)) for tenants who own homes in manufactured/mobile home 9 10 parks to relocate when the park in which they reside is closed or 11 converted to another use. Many ((mobile home)) such tenants need 12 financial assistance in order to ((move their mobile homes from a)) relocate from a manufactured/mobile home park. The purpose of this 13 14 chapter is to provide a mechanism for assisting manufactured/mobile 15 home tenants to relocate their manufactured/mobile homes to suitable 16 alternative sites ((when the mobile home park in which they reside is closed or converted to another use)) or demolish and dispose of their 17 18 homes and secure housing.

Sec. 2. RCW 59.21.010 and 2009 c 565 s 47 are each reenacted and amended to read as follows: Unless the context clearly requires otherwise, the definitions in
 this section apply throughout this chapter.

(1) "Department" means the department of commerce.

4

(2) "Director" means the director of the department of commerce.

5 (3) "Fund" means the <u>manufactured/</u>mobile home park relocation 6 fund established under RCW 59.21.050.

7 (4) "Landlord" or "park-owner" means the owner of the 8 <u>manufactured/</u>mobile home park that is being closed at the time 9 relocation assistance is provided.

10 (5) "Low-income household" means a single person, family, or 11 unrelated persons living together whose adjusted income is less than 12 eighty percent of the median family income, adjusted for household 13 size, for the county where the manufactured/mobile home is located.

14 <u>(6)</u> "<u>Manufactured/mobile home park</u>" or "park" means real property 15 that is rented or held out for rent to others for the placement of 16 two or more <u>manufactured/mobile</u> homes for the primary purpose of 17 production of income, except where the real property is rented or 18 held out for rent for seasonal recreational purpose only and is not 19 intended for year-round occupancy.

26 (((-7))) (8) "Relocation assistance" means the monetary assistance 27 provided under this chapter.

28 (9) "Tenant" means a person that owns a manufactured/mobile home
29 located on a rented lot in a manufactured/mobile home park.

30 Sec. 3. RCW 59.21.021 and 2005 c 399 s 5 are each amended to 31 read as follows:

(1) If a <u>manufactured/mobile home park is closed or converted to</u> another use ((after December 31, 1995)), eligible tenants shall be entitled to <u>relocation</u> assistance on a first-come, first-serve basis. The department shall give priority for distribution of relocation assistance to <u>eligible</u> tenants residing in parks that are closed as a result of park-owner fraud or as a result of health and safety concerns as determined by the local board of health. Payments shall 1 be made upon the department's verification of eligibility, subject to 2 the availability of remaining funds.

3 <u>(2)</u> Eligibility for relocation assistance funds is limited to 4 low-income households. ((As used in this section, "low-income 5 household" means a single person, family, or unrelated persons living 6 together whose adjusted income is less than eighty percent of the 7 median family income, adjusted for household size, for the county 8 where the mobile or manufactured home is located.

9 (2) Assistance for closures occurring after December 31, 1995, is 10 limited to persons who maintain ownership of and relocate their 11 mobile home or who dispose of a home not relocatable to a new site.))

(3) ((Persons)) Eligible tenants who ((removed and disposed of their mobile home or maintained ownership of and relocated their mobile homes)) relocate are entitled to reimbursement of actual relocation expenses from the fund up to a maximum of twelve thousand dollars for a ((double-wide)) multisection home and up to a maximum of seven thousand five hundred dollars for a single-((wide)) section home.

19 (4) Any individual or organization may apply to receive funds from the ((mobile home park relocation)) fund, for use in combination 20 21 with funds from public or private sources, toward relocation of tenants eligible under this section, with agreement from the tenant. 22 ((Funds received from the mobile home park relocation fund shall only 23 be used for relocation assistance expenses or other mobile/ 24 25 manufactured home ownership expenses, that include down payment 26 assistance, if the owners are not planning to relocate their mobile 27 home as long as their original home is removed from the park.))

28 Sec. 4. RCW 59.21.025 and 1998 c 124 s 3 are each amended to 29 read as follows:

(((1))) If financial assistance for relocation is obtained from 30 31 sources other than the ((mobile home park relocation)) fund ((established under this chapter)), then the relocation assistance 32 33 provided to any person ((under this chapter)) from the fund shall be reduced as necessary to ensure that no person receives financial 34 assistance for relocation from all sources combined ((more than: (a) 35 That person's actual cost of relocation; or (b) seven thousand 36 37 dollars for a double-wide mobile home and three thousand five hundred 38 dollars for a single-wide mobile home.

1 (2) When a person receives financial assistance for relocation 2 from a source other than the mobile home park relocation assistance 3 fund, then the assistance received from the fund will be the 4 difference between the maximum amount to which a person is entitled 5 under RCW 59.21.021(3) and the amount of assistance received from the 6 outside source.

7 (3) If the amount of assistance received from an outside source 8 exceeds the maximum amounts of assistance to which a person is 9 entitled under RCW 59.21.021(3), then that person will not receive 10 any assistance from the mobile home park relocation assistance fund)) 11 in excess of that person's actual relocation expenses.

12 Sec. 5. RCW 59.21.050 and 2011 c 158 s 7 are each amended to 13 read as follows:

(1) The existence of the manufactured/mobile home park relocation 14 15 fund in the custody of the state treasurer is affirmed. Expenditures 16 from the fund may be used only for relocation assistance awarded under this chapter and the department's costs as provided in 17 18 subsection (3) of this section. Only the director or the director's designee may authorize expenditures from the fund. All relocation 19 assistance payments to tenants under this chapter shall be made from 20 the fund. The fund is subject to allotment procedures under chapter 21 22 43.88 RCW, but no appropriation is required for expenditures.

(2) A ((park)) tenant is eligible for <u>relocation</u> assistance under 23 24 this chapter only after an application is submitted by that tenant or 25 an organization acting on the tenant's account under RCW 59.21.021(4) on a form approved by the director ((which)). The application shall 26 27 include: (a) ((For those persons who maintained ownership of and relocated their homes or removed their homes from the park: (i)) A 28 copy of the notice from the park-owner, or other adequate proof, that 29 30 the tenancy is terminated due to closure of the park or its conversion to another use; ((((ii))) (b) a copy of the rental 31 32 agreement then in force, or other proof that the applicant was a tenant at the time of notice of closure; (((iii) a copy of the 33 contract for relocating the home which includes the date of 34 35 relocation, or other)) (c) proof of actual relocation expenses incurred on a date certain; ((and (iv))) (d) proof of ownership of 36 the home at the time of notice of closure; and (e) a statement of any 37 38 other available assistance( $(\div)$ ) <u>received</u>.

1 (((b) For those persons who sold their homes and incurred no relocation expenses: (i) A copy of the notice from the park-owner, or 2 other adequate proof, that the tenancy is terminated due to closure 3 of the park or its conversion to another use; (ii) a copy of the 4 rental agreement then in force, or other proof that the applicant was 5 6 a tenant at the time of notice of closure; and (iii) a copy of the record of title transfer issued by the department of licensing when 7 the tenant sold the home rather than relocate it due to park closure 8 or conversion.)) 9

10 (3) The department may deduct a percentage amount of the fee 11 collected under RCW 46.17.155 for administration expenses incurred by 12 the department.
