**SUBSTITUTE SENATE BILL 5236**

1 AN ACT Relating to encouraging apprenticeships; amending RCW  
2 28B.77.230; adding a new section to chapter 49.04 RCW; and creating a  
3 new section.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 NEW SECTION. **Sec. 1.** The legislature finds that interest in  
6 registered apprenticeships is increasing, with applications to the  
7 department of labor and industries rising from five programs in 2017  
8 to eleven programs in 2018. Those programs spanned only nine  
9 occupations in 2017, but rose to cover twenty-seven in 2018. The  
10 legislature intends to build on the success of the incumbent worker  
11 training programs by providing resources to develop them into full  
12 registered apprenticeships that are sustainable and less susceptible  
13 to short-term budget cycles.

14 NEW SECTION. **Sec. 2.** A new section is added to chapter 49.04  
15 RCW to read as follows:

16 (1) Subject to appropriation, the department of labor and  
17 industries shall, through the supervisor of apprenticeship, employ a  
18 coordinator to do outreach and assist in establishing registered  
19 apprenticeship programs where they do not exist in state government,  
20 public education, and the health care industry.

1 (2) The office of financial management shall work with the  
2 coordinator established in subsection (1) of this section to do  
3 outreach and assist in establishing apprenticeship and training  
4 programs where they do not exist in state government.

5 (3) The office of the superintendent of public instruction shall  
6 work with the coordinator established in subsection (1) of this  
7 section to do outreach and assist in establishing apprenticeship and  
8 training programs where they do not exist in public education.

9 (4) The department of health shall work with the coordinator  
10 established in subsection (1) of this section and health professional  
11 associations to do outreach and assist in establishing apprenticeship  
12 and training programs where they do not exist in the health care  
13 industry.

14 **Sec. 3.** RCW 28B.77.230 and 2012 c 229 s 116 are each amended to  
15 read as follows:

16 (1) The council, the state board for community and technical  
17 colleges, the council of presidents, the four-year institutions of  
18 higher education, the private independent higher education  
19 institutions, and the private career schools shall collaborate to  
20 carry out the following goals:

21 (a) Increase the number of students who receive academic credit  
22 for prior learning and the number of students who receive credit for  
23 prior learning that counts towards their major or towards earning  
24 their degree, certificate, or credential, while ensuring that credit  
25 is awarded only for high quality, course-level competencies;

26 (b) Increase the number and type of academic credits accepted for  
27 prior learning in institutions of higher education, while ensuring  
28 that credit is awarded only for high quality, course-level  
29 competencies;

30 (c) Develop transparent policies and practices in awarding  
31 academic credit for prior learning;

32 (d) Improve prior learning assessment practices across the  
33 institutions of higher education;

34 (e) Create tools to develop faculty and staff knowledge and  
35 expertise in awarding credit for prior learning and to share  
36 exemplary policies and practices among institutions of higher  
37 education;

1 (f) Develop articulation agreements when patterns of credit for  
2 prior learning are identified for particular programs and pathways;  
3 and  
4 (g) Develop outcome measures to track progress on the goals  
5 outlined in this section.  
6 (2) The council shall convene the academic credit for prior  
7 learning work group.  
8 (a) The work group must include the following members:  
9 (i) One representative from the council;  
10 (ii) One representative from the state board for community and  
11 technical colleges;  
12 (iii) One representative from the council of presidents;  
13 (iv) Two representatives each from faculty from two and four-year  
14 institutions of higher education;  
15 (v) Two representatives from private career schools;  
16 (vi) Two representatives from business; ~~((and))~~  
17 (vii) Two representatives from labor; and  
18 (viii) Two representatives from licensed health care professions.  
19 (b) The purpose of the work group is to coordinate and implement  
20 the goals in subsection (1) of this section.  
21 (3) The council shall report progress on the goals and outcome  
22 measures annually by December ~~((31st))~~ 10th.  
23 (4) For the purposes of this section, "prior learning" means the  
24 knowledge and skills gained through work and life experience; through  
25 military training and experience; through hours of work and  
26 instruction as a registered apprentice; and through formal and  
27 informal education and training from in-state and out-of-state  
28 institutions including foreign institutions.
