1 AN ACT Relating to physician assistants; amending RCW 18.71A.020,
2 18.71A.025, 18.71A.030, 18.71A.050, 18.71A.060, 18.71A.090, 7.68.030,
3 18.06.140, 18.57.003, 18.79.040, 18.79.060, 18.79.240, 18.79.270,
4 18.100.050, 18.120.020, 18.130.410, 18.250.010, 28A.210.090,

17 date.

18 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

19 NEW SECTION. **Sec. 1.** The legislature intends to modernize the
20 practice of physician assistants in order to increase access to care,
21 reduce barriers to employment of physician assistants, and optimize

1 the manner in which physician assistants deliver quality medical
2 care.

3 **Sec. 2.** RCW 18.71A.010 and 2019 c 55 s 5 are each reenacted and
4 amended to read as follows:

5 The definitions set forth in this section apply throughout this
6 chapter.

7 (1) "Commission" means the Washington medical commission.

8 (2) "Department" means the department of health.

9 (3) "Physician assistant" means a person who is licensed by the
10 commission to practice medicine (~~(to a limited extent only under the~~
11 ~~supervision of a physician as defined in chapter 18.71 RCW))~~
12 according to a practice agreement with one or more participating
13 physicians, with at least one of the physicians working in a
14 supervisory capacity, and who is academically and clinically prepared
15 to provide health care services and perform diagnostic, therapeutic,
16 preventative, and health maintenance services.

17 (4) "Practice medicine" has the meaning defined in RCW 18.71.011
18 and also includes the practice of osteopathic medicine and surgery as
19 defined in RCW 18.57.001.

20 (5) "Secretary" means the secretary of health or the secretary's
21 designee.

22 (6) "Physician" means a physician licensed under chapter 18.57 or
23 18.71 RCW.

24 (7) "Practice agreement" means an agreement entered under section
25 6 of this act.

26 **Sec. 3.** RCW 18.71A.020 and 2019 c 55 s 6 are each amended to
27 read as follows:

28 (1) The commission shall adopt rules fixing the qualifications
29 and the educational and training requirements for licensure as a
30 physician assistant or for those enrolled in any physician assistant
31 training program. The requirements shall include completion of an
32 accredited physician assistant training program approved by the
33 commission and within one year successfully take and pass an
34 examination approved by the commission, if the examination tests
35 subjects substantially equivalent to the curriculum of an accredited
36 physician assistant training program. An interim permit may be
37 granted by the department of health for one year provided the
38 applicant meets all other requirements. Physician assistants licensed

1 by the board of medical examiners, or the commission as of July 1,
2 1999, shall continue to be licensed.

3 (2) (a) The commission shall adopt rules governing the extent to
4 which:

5 (i) Physician assistant students may practice medicine during
6 training; and

7 (ii) Physician assistants may practice after successful
8 completion of a physician assistant training course.

9 (b) Such rules shall provide:

10 (i) That the practice of a physician assistant shall be limited
11 to the performance of those services for which he or she is trained;
12 and

13 (ii) That each physician assistant shall practice medicine only
14 under ~~((the supervision and control of a))~~ the terms of one or more
15 practice agreements, each signed by one or more supervising
16 physicians licensed in this state~~((, but such supervision and~~
17 ~~control))~~. A practice agreement may be signed electronically using a
18 method for electronic signatures approved by the commission.
19 Supervision shall not be construed to necessarily require the
20 personal presence of the supervising physician or physicians at the
21 place where services are rendered.

22 (3) Applicants for licensure shall file an application with the
23 commission on a form prepared by the secretary with the approval of
24 the commission, detailing the education, training, and experience of
25 the physician assistant and such other information as the commission
26 may require. The application shall be accompanied by a fee determined
27 by the secretary as provided in RCW 43.70.250 and 43.70.280. A
28 surcharge of fifty dollars per year shall be charged on each license
29 renewal or issuance of a new license to be collected by the
30 department and deposited into the impaired physician account for
31 physician assistant participation in the impaired physician program.
32 Each applicant shall furnish proof satisfactory to the commission of
33 the following:

34 (a) That the applicant has completed an accredited physician
35 assistant program approved by the commission and is eligible to take
36 the examination approved by the commission;

37 (b) That the applicant is of good moral character; and

38 (c) That the applicant is physically and mentally capable of
39 practicing medicine as a physician assistant with reasonable skill
40 and safety. The commission may require an applicant to submit to such

1 examination or examinations as it deems necessary to determine an
2 applicant's physical or mental capability, or both, to safely
3 practice as a physician assistant.

4 (4) (a) The commission may approve, deny, or take other
5 disciplinary action upon the application for license as provided in
6 the Uniform Disciplinary Act, chapter 18.130 RCW.

7 (b) The license shall be renewed as determined under RCW
8 43.70.250 and 43.70.280. The commission shall request licensees to
9 submit information about their current professional practice at the
10 time of license renewal and licensees must provide the information
11 requested. This information may include practice setting, medical
12 specialty, or other relevant data determined by the commission.

13 ~~((c) The commission may authorize the use of alternative
14 supervisors who are licensed either under chapter 18.57 or 18.71
15 RCW.))~~

16 (5) All funds in the impaired physician account shall be paid to
17 the contract entity within sixty days of deposit.

18 **Sec. 4.** RCW 18.71A.025 and 1986 c 259 s 106 are each amended to
19 read as follows:

20 (1) The uniform disciplinary act, chapter 18.130 RCW, governs the
21 issuance and denial of licenses and the discipline of licensees under
22 this chapter.

23 (2) The commission shall consult with the board of osteopathic
24 medicine and surgery when investigating allegations of unprofessional
25 conduct against a licensee who has a supervising physician licensed
26 under chapter 18.57 RCW.

27 **Sec. 5.** RCW 18.71A.030 and 2016 c 155 s 23 are each amended to
28 read as follows:

29 (1) A physician assistant may practice medicine in this state
30 ~~((only with the approval of the delegation agreement by the
31 commission and only))~~ to the extent permitted by the ~~((commission. A
32 physician assistant who has received a license but who has not
33 received commission approval of the delegation agreement under RCW
34 18.71A.040 may not))~~ practice agreement. A physician assistant shall
35 be subject to discipline under chapter 18.130 RCW.

36 (2) Physician assistants may provide services that they are
37 competent to perform based on their education, training, and
38 experience and that are consistent with their ~~((commission-approved~~

1 ~~delegation))~~ practice agreement. The supervising physician and the
2 physician assistant shall determine which procedures may be performed
3 and the ~~((degree—of))~~ supervision under which the procedure is
4 performed. Physician assistants may practice in any area of medicine
5 or surgery as long as the practice is not beyond the supervising
6 physician's own scope of expertise and clinical practice and the
7 practice agreement.

8 NEW SECTION. **Sec. 6.** A new section is added to chapter 18.71A
9 RCW to read as follows:

10 (1) Prior to commencing practice, a physician assistant licensed
11 in Washington state must enter into a practice agreement with a
12 physician or group of physicians, at least one of whom must be
13 working in a supervisory capacity.

14 (a) Entering into a practice agreement is voluntary for the
15 physician assistant and the supervising physician. A physician may
16 not be compelled to participate in a practice agreement as a
17 condition of employment.

18 (b) Prior to entering into the practice agreement, the physician,
19 physicians, or their designee must verify the physician assistant's
20 credentials.

21 (c) The protections of RCW 43.70.075 apply to any physician who
22 reports to the commission acts of retaliation or reprisal for
23 declining to sign a practice agreement.

24 (d) The practice agreement must be maintained by the physician
25 assistant's employer or at his or her place of work and must be made
26 available to the commission upon request.

27 (e) The commission shall develop a model practice agreement.

28 (f) The commission shall establish administrative procedures,
29 administrative requirements, and fees as provided in RCW 43.70.250
30 and 43.70.280.

31 (2) A practice agreement must include all of the following:

32 (a) The duties and responsibilities of the physician assistant,
33 the supervising physician, and alternate physicians. The practice
34 agreement must describe supervision requirements for specified
35 procedures or areas of practice. The practice agreement may only
36 include acts, tasks, or functions that the physician assistant and
37 supervising physician or alternate physicians are qualified to
38 perform by education, training, or experience and that are within the
39 scope of expertise and clinical practice of both the physician

1 assistant and the supervising physician or alternate physicians,
2 unless otherwise authorized by law, rule, or the commission;

3 (b) A process between the physician assistant and supervising
4 physician or alternate physicians for communication, availability,
5 and decision making when providing medical treatment to a patient or
6 in the event of an acute health care crisis not previously covered by
7 the practice agreement, such as a flu pandemic or other unforeseen
8 emergency. Communications may occur in person, electronically, by
9 telephone, or by an alternate method;

10 (c) If there is only one physician party to the practice
11 agreement, a protocol for designating an alternate physician for
12 consultation in situations in which the physician is not available;

13 (d) The signature of the physician assistant and the signature or
14 signatures of the supervising physician. A practice agreement may be
15 signed electronically using a method for electronic signatures
16 approved by the commission; and

17 (e) A termination provision. A physician assistant or physician
18 may terminate the practice agreement as it applies to a single
19 supervising physician without terminating the agreement with respect
20 to the remaining participating physicians. If the termination results
21 in no supervising physician being designated on the agreement, a new
22 supervising physician must be designated for the agreement to be
23 valid.

24 (i) Except as provided in (e)(ii) of this subsection, the
25 physician assistant or supervising physician must provide written
26 notice at least thirty days prior to the termination.

27 (ii) The physician assistant or supervising physician may
28 terminate the practice agreement immediately due to good faith
29 concerns regarding unprofessional conduct or failure to practice
30 medicine while exercising reasonable skill and safety.

31 (3) A practice agreement may be amended for any reason, such as
32 to add or remove supervising physicians or alternate physicians or to
33 amend the duties and responsibilities of the physician assistant.

34 (4) Whenever a physician assistant is practicing in a manner
35 inconsistent with the practice agreement, the commission may take
36 disciplinary action under chapter 18.130 RCW.

37 (5) Whenever a physician is subject to disciplinary action under
38 chapter 18.130 RCW related to the practice of a physician assistant,
39 the case must be referred to the appropriate disciplining authority.

1 (6) A physician assistant or physician may participate in more
2 than one practice agreement if he or she is reasonably able to
3 fulfill the duties and responsibilities in each agreement.

4 **Sec. 7.** RCW 18.71A.050 and 1994 sp.s. c 9 s 323 are each amended
5 to read as follows:

6 No physician who (~~supervises~~) enters into a practice agreement
7 with a licensed physician assistant in accordance with and within the
8 terms of any permission granted by the commission is considered as
9 aiding and abetting an unlicensed person to practice medicine. The
10 supervising physician and physician assistant shall each retain
11 professional and personal responsibility for any act which
12 constitutes the practice of medicine as defined in RCW 18.71.011 or
13 the practice of osteopathic medicine and surgery as defined in RCW
14 18.57.001 when performed by the physician assistant.

15 **Sec. 8.** RCW 18.71A.060 and 1994 sp.s. c 9 s 324 are each amended
16 to read as follows:

17 No health care services may be performed under this chapter in
18 any of the following areas:

19 (1) The measurement of the powers or range of human vision, or
20 the determination of the accommodation and refractive state of the
21 human eye or the scope of its functions in general, or the fitting or
22 adaptation of lenses or frames for the aid thereof.

23 (2) The prescribing or directing the use of, or using, any
24 optical device in connection with ocular exercises, visual training,
25 vision training, or orthoptics.

26 (3) The prescribing of contact lenses for, or the fitting or
27 adaptation of contact lenses to, the human eye.

28 (4) Nothing in this section shall preclude the performance of
29 routine visual screening.

30 (5) The practice of dentistry or dental hygiene as defined in
31 chapters 18.32 and 18.29 RCW respectively. The exemptions set forth
32 in RCW 18.32.030 (1) and (8), shall not apply to a physician
33 assistant.

34 (6) The practice of chiropractic as defined in chapter 18.25 RCW
35 including the adjustment or manipulation of the articulations of the
36 spine. Nothing in this subsection prohibits a physician assistant
37 from performing tasks within the scope of practice of a physician
38 licensed under chapter 18.57 RCW if one or more supervising

1 physicians in the physician assistant's practice agreement are
2 licensed under chapter 18.57 RCW.

3 (7) The practice of podiatric medicine and surgery as defined in
4 chapter 18.22 RCW.

5 **Sec. 9.** RCW 18.71A.090 and 2007 c 264 s 3 are each amended to
6 read as follows:

7 (1) A physician assistant may sign and attest to any
8 certificates, cards, forms, or other required documentation that the
9 physician assistant's supervising physician or physician group may
10 sign, provided that it is within the physician assistant's scope of
11 practice and is consistent with the terms of the physician
12 assistant's practice (~~(arrangement plan)~~) agreement as required by
13 this chapter.

14 (2) Notwithstanding any federal law, rule, or medical staff bylaw
15 provision to the contrary, a physician is not required to countersign
16 orders written in a patient's clinical record or an official form by
17 a physician assistant with whom the physician has a practice
18 agreement.

19 NEW SECTION. **Sec. 10.** A new section is added to chapter 18.71A
20 RCW to read as follows:

21 (1) The commission shall conduct an education and outreach
22 campaign to make license holders, health carriers, and the public
23 aware of the provisions of this act.

24 (2) This section expires August 1, 2023.

25 NEW SECTION. **Sec. 11.** A new section is added to chapter 18.71A
26 RCW to read as follows:

27 (1) On or after the effective date of this section, no new
28 licenses may be issued under chapter 18.57A RCW. The commission shall
29 license physician assistants licensed under chapter 18.57A RCW prior
30 to the effective date of this section as physician assistants under
31 this chapter when they renew their licenses.

32 (2) The board of osteopathic medicine and surgery remains the
33 disciplining authority under chapter 18.130 RCW for conduct occurring
34 while a physician assistant is licensed under chapter 18.57A RCW.

35 NEW SECTION. **Sec. 12.** A new section is added to chapter 18.71A
36 RCW to read as follows:

1 The commission and the board of osteopathic medicine and surgery
2 shall adopt any rules necessary to implement this act.

3 **Sec. 13.** RCW 7.68.030 and 2017 c 235 s 2 are each amended to
4 read as follows:

5 (1) It shall be the duty of the director to establish and
6 administer a program of benefits to innocent victims of criminal acts
7 within the terms and limitations of this chapter. The director may
8 apply for and, subject to appropriation, expend federal funds under
9 Public Law 98-473 and any other federal program providing financial
10 assistance to state crime victim compensation programs. The federal
11 funds shall be deposited in the state general fund and may be
12 expended only for purposes authorized by applicable federal law.

13 (2) The director shall:

14 (a) Establish and adopt rules governing the administration of
15 this chapter in accordance with chapter 34.05 RCW;

16 (b) Regulate the proof of accident and extent thereof, the proof
17 of death, and the proof of relationship and the extent of dependency;

18 (c) Supervise the medical, surgical, and hospital treatment to
19 the intent that it may be in all cases efficient and up to the
20 recognized standard of modern surgery;

21 (d) Issue proper receipts for moneys received and certificates
22 for benefits accrued or accruing;

23 (e) Designate a medical director who is licensed under chapter
24 18.57 or 18.71 RCW;

25 (f) Supervise the providing of prompt and efficient care and
26 treatment, including care provided by physician assistants governed
27 by the provisions of (~~chapters 18.57A and~~) chapter 18.71A RCW,
28 acting under a supervising physician, including chiropractic care,
29 and including care provided by licensed advanced registered nurse
30 practitioners, to victims at the least cost consistent with
31 promptness and efficiency, without discrimination or favoritism, and
32 with as great uniformity as the various and diverse surrounding
33 circumstances and locations of industries will permit and to that end
34 shall, from time to time, establish and adopt and supervise the
35 administration of printed forms, electronic communications, rules,
36 regulations, and practices for the furnishing of such care and
37 treatment. The medical coverage decisions of the department do not
38 constitute a "rule" as used in RCW 34.05.010(16), nor are such
39 decisions subject to the rule-making provisions of chapter 34.05 RCW

1 except that criteria for establishing medical coverage decisions
2 shall be adopted by rule. The department may recommend to a victim
3 particular health care services and providers where specialized
4 treatment is indicated or where cost-effective payment levels or
5 rates are obtained by the department, and the department may enter
6 into contracts for goods and services including, but not limited to,
7 durable medical equipment so long as statewide access to quality
8 service is maintained for injured victims;

9 (g) In consultation with interested persons, establish and, in
10 his or her discretion, periodically change as may be necessary, and
11 make available a fee schedule of the maximum charges to be made by
12 any physician, surgeon, chiropractor, hospital, druggist, licensed
13 advanced registered nurse practitioner, and physician assistants as
14 defined in (~~chapters 18.57A and~~) chapter 18.71A RCW, acting under a
15 supervising physician or other agency or person rendering services to
16 victims. The department shall coordinate with other state purchasers
17 of health care services to establish as much consistency and
18 uniformity in billing and coding practices as possible, taking into
19 account the unique requirements and differences between programs. No
20 service covered under this title, including services provided to
21 victims, whether aliens or other victims, who are not residing in the
22 United States at the time of receiving the services, shall be charged
23 or paid at a rate or rates exceeding those specified in such fee
24 schedule, and no contract providing for greater fees shall be valid
25 as to the excess. The establishment of such a schedule, exclusive of
26 conversion factors, does not constitute "agency action" as used in
27 RCW 34.05.010(3), nor does such a fee schedule constitute a "rule" as
28 used in RCW 34.05.010(16). Payments for providers' services under the
29 fee schedule established pursuant to this subsection (2) may not be
30 less than payments provided for comparable services under the
31 workers' compensation program under Title 51 RCW, provided:

32 (i) If the department, using caseload estimates, projects a
33 deficit in funding for the program by July 15th for the following
34 fiscal year, the director shall notify the governor and the
35 appropriate committees of the legislature and request funding
36 sufficient to continue payments to not less than payments provided
37 for comparable services under the workers' compensation program. If
38 sufficient funding is not provided to continue payments to not less
39 than payments provided for comparable services under the workers'
40 compensation program, the director shall reduce the payments under

1 the fee schedule for the following fiscal year based on caseload
2 estimates and available funding, except payments may not be reduced
3 to less than seventy percent of payments for comparable services
4 under the workers' compensation program;

5 (ii) If an unforeseeable catastrophic event results in
6 insufficient funding to continue payments to not less than payments
7 provided for comparable services under the workers' compensation
8 program, the director shall reduce the payments under the fee
9 schedule to not less than seventy percent of payments provided for
10 comparable services under the workers' compensation program, provided
11 that the reduction may not be more than necessary to fund benefits
12 under the program; and

13 (iii) Once sufficient funding is provided or otherwise available,
14 the director shall increase the payments under the fee schedule to
15 not less than payments provided for comparable services under the
16 workers' compensation program;

17 (h) Make a record of the commencement of every disability and the
18 termination thereof and, when bills are rendered for the care and
19 treatment of injured victims, shall approve and pay those which
20 conform to the adopted rules, regulations, established fee schedules,
21 and practices of the director and may reject any bill or item thereof
22 incurred in violation of the principles laid down in this section or
23 the rules, regulations, or the established fee schedules and rules
24 and regulations adopted under it.

25 (3) The director and his or her authorized assistants:

26 (a) Have power to issue subpoenas to enforce the attendance and
27 testimony of witnesses and the production and examination of books,
28 papers, photographs, tapes, and records before the department in
29 connection with any claim made to the department or any billing
30 submitted to the department. The superior court has the power to
31 enforce any such subpoena by proper proceedings;

32 (b) (i) May apply for and obtain a superior court order approving
33 and authorizing a subpoena in advance of its issuance. The
34 application may be made in the county where the subpoenaed person
35 resides or is found, or the county where the subpoenaed records or
36 documents are located, or in Thurston county. The application must
37 (A) state that an order is sought pursuant to this subsection; (B)
38 adequately specify the records, documents, or testimony; and (C)
39 declare under oath that an investigation is being conducted for a
40 lawfully authorized purpose related to an investigation within the

1 department's authority and that the subpoenaed documents or testimony
2 are reasonably related to an investigation within the department's
3 authority.

4 (ii) Where the application under this subsection (3)(b) is made
5 to the satisfaction of the court, the court must issue an order
6 approving the subpoena. An order under this subsection constitutes
7 authority of law for the agency to subpoena the records or testimony.

8 (iii) The director and his or her authorized assistants may seek
9 approval and a court may issue an order under this subsection without
10 prior notice to any person, including the person to whom the subpoena
11 is directed and the person who is the subject of an investigation.

12 (4) In all hearings, actions, or proceedings before the
13 department, any physician or licensed advanced registered nurse
14 practitioner having theretofore examined or treated the claimant may
15 be required to testify fully regarding such examination or treatment,
16 and shall not be exempt from so testifying by reason of the relation
17 of the physician or licensed advanced registered nurse practitioner
18 to the patient.

19 **Sec. 14.** RCW 18.06.140 and 2019 c 308 s 9 are each amended to
20 read as follows:

21 (1) When a person licensed under this chapter sees patients with
22 potentially serious disorders such as cardiac conditions, acute
23 abdominal symptoms, and such other conditions, the practitioner shall
24 immediately request a consultation or recent written diagnosis from a
25 primary health care provider licensed under chapter 18.71, 18.57,
26 (~~18.57A,~~) 18.36A, or 18.71A RCW or RCW 18.79.050. In the event that
27 the patient with the disorder refuses to authorize such consultation
28 or provide a recent diagnosis from such primary health care provider,
29 acupuncture or Eastern medicine treatments may only be continued
30 after the patient signs a written waiver acknowledging the risks
31 associated with the failure to pursue treatment from a primary health
32 care provider. The waiver must also include: (a) An explanation of an
33 acupuncturist's or acupuncture and Eastern medicine practitioner's
34 scope of practice, including the services and techniques
35 acupuncturists or acupuncture and Eastern medicine practitioners are
36 authorized to provide and (b) a statement that the services and
37 techniques that an acupuncturist or acupuncture and Eastern medicine
38 practitioner is authorized to provide will not resolve the patient's

1 underlying potentially serious disorder. The requirements of the
2 waiver shall be established by the secretary in rule.

3 (2) In an emergency, a person licensed under this chapter shall:
4 (a) Initiate the emergency medical system by calling 911; (b) request
5 an ambulance; and (c) provide patient support until emergency
6 response arrives.

7 (3) A person violating this section is guilty of a misdemeanor.

8 **Sec. 15.** RCW 18.57.003 and 2017 c 101 s 1 are each amended to
9 read as follows:

10 There is hereby created an agency of the state of Washington,
11 consisting of eleven individuals appointed by the governor to be
12 known as the Washington state board of osteopathic medicine and
13 surgery.

14 On expiration of the term of any member, the governor shall
15 appoint for a period of five years a qualified individual to take the
16 place of such member. Each member shall hold office until the
17 expiration of the term for which such member is appointed or until a
18 successor shall have been appointed and shall have qualified. Initial
19 appointments shall be made and vacancies in the membership of the
20 board shall be filled for the unexpired term by appointment by the
21 governor.

22 Each member of the board shall be a citizen of the United States
23 and must be an actual resident of this state. Two members must be
24 consumers who have neither a financial nor a fiduciary relationship
25 to a health care delivery system, (~~one member must have been in~~
26 ~~active practice as a licensed osteopathic physician assistant in this~~
27 ~~state for at least five years immediately preceding appointment,)~~
28 and every other member must have been in active practice as a
29 licensed osteopathic physician and surgeon in this state for at least

12 use as a component of any article specified in (1), (2), or (3) of
13 this subsection. The term does not include devices or their
14 components, parts, or accessories.

15 (q) "Drug enforcement administration" means the drug enforcement
16 administration in the United States Department of Justice, or its
17 successor agency.

18 (r) "Electronic communication of prescription information" means
19 the transmission of a prescription or refill authorization for a drug
20 of a practitioner using computer systems. The term does not include a
21 prescription or refill authorization verbally transmitted by
22 telephone nor a facsimile manually signed by the practitioner.

23 (s) "Immature plant or clone" means a plant or clone that has no
24 flowers, is less than twelve inches in height, and is less than
25 twelve inches in diameter.

26 (t) "Immediate precursor" means a substance:

27 (1) that the commission has found to be and by rule designates as
28 being the principal compound commonly used, or produced primarily for
29 use, in the manufacture of a controlled substance;

30 (2) that is an immediate chemical intermediary used or likely to
31 be used in the manufacture of a controlled substance; and

2 concentrates, useable marijuana, or marijuana-infused product

4 uniform within recognized tolerances for the factors that appear in
5 the labeling.

6 (w) "Lot number" must identify the licensee by business or trade
7 name and Washington state unified business identifier number, and the
8 date of harvest or processing for each lot of marijuana, marijuana
9 concentrates, useable marijuana, or marijuana-infused product.

10 (x) "Manufacture" means the production, preparation, propagation,
11 compounding, conversion, or processing of a controlled substance,
12 either directly or indirectly or by extraction from substances of
13 natural origin, or independently by means of chemical synthesis, or
14 by a combination of extraction and chemical synthesis, and includes
15 any packaging or repackaging of the substance or labeling or
16 relabeling of its container. The term does not include the
17 preparation, compounding, packaging, repackaging, labeling, or
18 relabeling of a controlled substance:

19 (1) by a practitioner as an incident to the practitioner's
20 administering or dispensing of a controlled substance in the course
21 of the practitioner's professional practice; or

22 (2) by a practitioner, or by the practitioner's authorized agent
23 under the practitioner's supervision, for the purpose of, or as an
24 incident to, research, teaching, or chemical analysis and not for
25 sale.

26 (y) "Marijuana" or "marihuana" means all parts of the plant
27 *Cannabis*, whether growing or not, with a THC concentration greater
28 than 0.3 percent on a dry weight basis; the seeds thereof; the resin
29 extracted from any part of the plant; and every compound,
30 manufacture, salt, derivative, mixture, or preparation of the plant,

2 in part of the resin extracted from any part of the plant *Cannabis*
3 and having a THC concentration greater than ten percent.

4 (aa) "Marijuana processor" means a person licensed by the state
5 liquor and cannabis board to process marijuana into marijuana
6 concentrates, useable marijuana, and marijuana-infused products,
7 package and label marijuana concentrates, useable marijuana, and
8 marijuana-infused products for sale in retail outlets, and sell
9 marijuana concentrates, useable marijuana, and marijuana-infused
10 products at wholesale to marijuana retailers.

11 (bb) "Marijuana producer" means a person licensed by the state
12 liquor and cannabis board to produce and sell marijuana at wholesale
13 to marijuana processors and other marijuana producers.

14 (cc) "Marijuana products" means useable marijuana, marijuana
15 concentrates, and marijuana-infused products as defined in this
16 section.

17 (dd) "Marijuana researcher" means a person licensed by the state
18 liquor and cannabis board to produce, process, and possess marijuana
19 for the purposes of conducting research on marijuana and marijuana-
20 derived drug products.

21 (ee) "Marijuana retailer" means a person licensed by the state
22 liquor and cannabis board to sell marijuana concentrates, useable
23 marijuana, and marijuana-infused products in a retail outlet.

24 (ff) "Marijuana-infused products" means products that contain
25 marijuana or marijuana extracts, are intended for human use, are
26 derived from marijuana as defined in subsection (y) of this section,
27 and have a THC concentration no greater than ten percent. The term
28 "marijuana-infused products" does not include either useable
29 marijuana or marijuana concentrates.

30 (gg) "Narcotic drug" means any of the following, whether produced
31 directly or indirectly by extraction from substances of vegetable
32 origin, or independently by means of chemical synthesis, or by a

15 (hh) "Opiate" means any substance having an addiction-forming or

17 of conversion into a drug having addiction-forming or addiction-
18 sustaining liability. The term includes opium, substances derived
19 from opium (opium derivatives), and synthetic opiates. The term does
20 not include, unless specifically designated as controlled under RCW
21 69.50.201, the dextrorotatory isomer of 3-methoxy-n-methylmorphinan

11 tetrahydrocannabinolic acid in any part of the plant *Cannabis*

13 (vv) "Ultimate user" means an individual who lawfully possesses a
14 controlled substance for the individual's own use or for the use of a
15 member of the individual's household or for administering to an
16 animal owned by the individual or by a member of the individual's

18 (ww) "Useable marijuana" means dried marijuana flowers. The term
19 "useable marijuana" does not include either marijuana-infused

21 medical or pharmaceutical care to the patients of the facility or

15 chapter 18.205 RCW that certifies the individual to provide substance

19 should be detained for a period of either evaluation or treatment, or

23 (10) "Crisis stabilization unit" means a short-term facility or a

18 (20) "Evaluation and treatment facility" means any facility which
19 can provide directly, or by direct arrangement with other public or
20 private agencies, emergency evaluation and treatment, outpatient

22 from a mental disorder, and which is licensed or certified as such by
23 the department. The authority may certify single beds as temporary
24 evaluation and treatment beds under RCW 71.05.745. A physically
25 separate and separately operated portion of a state hospital may be
26 designated as an evaluation and treatment facility. A facility which
27 is part of, or operated by, the department of social and health
28 services or any federal agency will not require certification. No
29 correctional institution or facility, or jail, shall be an evaluation

10 person presenting a likelihood of serious harm or the person becoming
11 gravely disabled within a reasonably short period of time;

12 (27) "Individualized service plan" means a plan prepared by a
13 developmental disabilities professional with other professionals as a
14 team, for a person with developmental disabilities, which shall
15 state:

16 (a) The nature of the person's specific problems, prior charged
17 criminal behavior, and habilitation needs;

18 (b) The conditions and strategies necessary to achieve the
19 purposes of habilitation;

20 (c) The intermediate and long-range goals of the habilitation
21 program, with a projected timetable for the attainment;

22 (d) The rationale for using this plan of habilitation to achieve
23 those intermediate and long-range goals;

24 (e) The staff responsible for carrying out the plan;

25 (f) Where relevant in light of past criminal behavior and due
26 consideration for public safety, the criteria for proposed movement
27 to less-restrictive settings, criteria for proposed eventual
28 discharge or release, and a projected possible date for discharge or
29 release; and

30 (g) The type of residence immediately anticipated for the person
31 and possible future types of residences;

32 (28) "Information related to mental health services" means all
33 information and records compiled, obtained, or maintained in the
34 course of providing services to either voluntary or involuntary
35 recipients of services by a mental health service provider. This may
36 include documents of legal proceedings under this chapter or chapter
37 71.34 or 10.77 RCW, or somatic health care information;

38 (29) "Intoxicated person" means a person whose mental or physical
39 functioning is substantially impaired as a result of the use of
40 alcohol or other psychoactive chemicals;

1 (30) "Judicial commitment" means a commitment by a court pursuant
2 to the provisions of this chapter;

3 (31) "Legal counsel" means attorneys and staff employed by county
4 prosecutor offices or the state attorney general acting in their
5 capacity as legal representatives of public mental health and
6 substance use disorder service providers under RCW 71.05.130;

7 (32) "Less restrictive alternative treatment" means a program of
8 individualized treatment in a less restrictive setting than inpatient
9 treatment that includes the services described in RCW 71.05.585;

10 (33) "Licensed physician" means a person licensed to practice
11 medicine or osteopathic medicine and surgery in the state of
12 Washington;

13 (34) "Likelihood of serious harm" means:

14 (a) A substantial risk that: (i) Physical harm will be inflicted
15 by a person upon his or her own person, as evidenced by threats or
16 attempts to commit suicide or inflict physical harm on oneself; (ii)
17 physical harm will be inflicted by a person upon another, as
18 evidenced by behavior which has caused such harm or which places
19 another person or persons in reasonable fear of sustaining such harm;
20 or (iii) physical harm will be inflicted by a person upon the
21 property of others, as evidenced by behavior which has caused
22 substantial loss or damage to the property of others; or

23 (b) The person has threatened the physical safety of another and
24 has a history of one or more violent acts;

25 (35) "Medical clearance" means a physician or other health care
26 provider has determined that a person is medically stable and ready
27 for referral to the designated crisis responder;

28 (36) "Mental disorder" means any organic, mental, or emotional
29 impairment which has substantial adverse effects on a person's
30 cognitive or volitional functions;

31 (37) "Mental health professional" means a psychiatrist,
32 psychologist, physician assistant working with a supervising
33 psychiatrist, psychiatric advanced registered nurse practitioner,
34 psychiatric nurse, or social worker, and such other mental health
35 professionals as may be defined by rules adopted by the secretary
36 pursuant to the provisions of this chapter;

37 (38) "Mental health service provider" means a public or private
38 agency that provides mental health services to persons with mental
39 disorders or substance use disorders as defined under this section
40 and receives funding from public sources. This includes, but is not

1 limited to, hospitals licensed under chapter 70.41 RCW, evaluation
2 and treatment facilities as defined in this section, community mental
3 health service delivery systems or community behavioral health
4 programs as defined in RCW 71.24.025, facilities conducting
5 competency evaluations and restoration under chapter 10.77 RCW,
6 approved substance use disorder treatment programs as defined in this
7 section, secure withdrawal management and stabilization facilities as
8 defined in this section, and correctional facilities operated by

10 (39) "Peace officer" means a law enforcement official of a public
11 agency or governmental unit, and includes persons specifically given
12 peace officer powers by any state law, local ordinance, or judicial
13 order of appointment;

14 (40) "Physician assistant" means a person licensed as a physician
15 assistant under chapter (~~(18.57A or)~~) 18.71A RCW;

16 (41) "Private agency" means any person, partnership, corporation,
17 or association that is not a public agency, whether or not financed
18 in whole or in part by public funds, which constitutes an evaluation
19 and treatment facility or private institution, or hospital, or
20 approved substance use disorder treatment program, which is conducted
21 for, or includes a department or ward conducted for, the care and
22 treatment of persons with mental illness, substance use disorders, or
23 both mental illness and substance use disorders;

24 (42) "Professional person" means a mental health professional,
25 substance use disorder professional, or designated crisis responder
26 and shall also mean a physician, physician assistant, psychiatric
27 advanced registered nurse practitioner, registered nurse, and such
28 others as may be defined by rules adopted by the secretary pursuant
29 to the provisions of this chapter;

30 (43) "Psychiatric advanced registered nurse practitioner" means a
31 person who is licensed as an advanced registered nurse practitioner
32 pursuant to chapter 18.79 RCW; and who is board certified in advanced
33 practice psychiatric and mental health nursing;

34 (44) "Psychiatrist" means a person having a license as a
35 physician and surgeon in this state who has in addition completed
36 three years of graduate training in psychiatry in a program approved
37 by the American medical association or the American osteopathic
38 association and is certified or eligible to be certified by the
39 American board of psychiatry and neurology;

1 (45) "Psychologist" means a person who has been licensed as a
2 psychologist pursuant to chapter 18.83 RCW;

3 (46) "Public agency" means any evaluation and treatment facility
4 or institution, secure withdrawal management and stabilization
5 facility, approved substance use disorder treatment program, or
6 hospital which is conducted for, or includes a department or ward
7 conducted for, the care and treatment of persons with mental illness,
8 substance use disorders, or both mental illness and substance use
9 disorders, if the agency is operated directly by federal, state,
10 county, or municipal government, or a combination of such
11 governments;

12 (47) "Release" means legal termination of the commitment under
13 the provisions of this chapter;

14 (48) "Resource management services" has the meaning given in
15 chapter 71.24 RCW;

16 (49) "Secretary" means the secretary of the department of health,
17 or his or her designee;

18 (50) "Secure withdrawal management and stabilization facility"
19 means a facility operated by either a public or private agency or by
20 the program of an agency which provides care to voluntary individuals
21 and individuals involuntarily detained and committed under this
22 chapter for whom there is a likelihood of serious harm or who are
23 gravely disabled due to the presence of a substance use disorder.
24 Secure withdrawal management and stabilization facilities must:

1 (52) "Social worker" means a person with a master's or further
2 advanced degree from a social work educational program accredited and
3 approved as provided in RCW 18.320.010;

4 (53) "Substance use disorder" means a cluster of cognitive,
5 behavioral, and physiological symptoms indicating that an individual
6 continues using the substance despite significant substance-related
7 problems. The diagnosis of a substance use disorder is based on a
8 pathological pattern of behaviors related to the use of the
9 substances;

10 (54) "Substance use disorder professional" means a person
11 certified as a substance use disorder professional by the department
12 of health under chapter 18.205 RCW;

13 (55) "Therapeutic court personnel" means the staff of a mental
14 health court or other therapeutic court which has jurisdiction over
15 defendants who are dually diagnosed with mental disorders, including
16 court personnel, probation officers, a court monitor, prosecuting
17 attorney, or defense counsel acting within the scope of therapeutic
18 court duties;

19 (56) "Treatment records" include registration and all other
20 records concerning persons who are receiving or who at any time have
21 received services for mental illness, which are maintained by the
22 department of social and health services, the department, the
23 authority, behavioral health administrative services organizations
24 and their staffs, managed care organizations and their staffs, and by
25 treatment facilities. Treatment records include mental health
26 information contained in a medical bill including but not limited to
27 mental health drugs, a mental health diagnosis, provider name, and
28 dates of service stemming from a medical service. Treatment records
29 do not include notes or records maintained for personal use by a
30 person providing treatment services for the department of social and
31 health services, the department, the authority, behavioral health

35 (57) "Triage facility" means a short-term facility or a portion

27 treatment program licensed or certified by the department as meeting
28 standards adopted under this chapter.

29 (4) "Authority" means the Washington state health care authority.

30 (5) "Available resources" means funds appropriated for the
31 purpose of providing community behavioral health programs, federal
32 funds, except those provided according to Title XIX of the Social
33 Security Act, and state funds appropriated under this chapter or
34 chapter 71.05 RCW by the legislature during any biennium for the
35 purpose of providing residential services, resource management
36 services, community support services, and other behavioral health
37 services. This does not include funds appropriated for the purpose of
38 operating and administering the state psychiatric hospitals.

1 (6) "Behavioral health administrative services organization"
2 means an entity contracted with the authority to administer
3 behavioral health services and programs under RCW 71.24.381,
4 including crisis services and administration of chapter 71.05 RCW,
5 the involuntary treatment act, for all individuals in a defined
6 regional service area.

7 (7) "Behavioral health provider" means a person licensed under

11 (8) "Behavioral health services" means mental health services as

17 (9) "Child" means a person under the age of eighteen years.

20 and meets at least one of the following criteria:

21 (a) Has undergone two or more episodes of hospital care for a
22 mental disorder within the preceding two years; or

23 (b) Has experienced a continuous psychiatric hospitalization or
24 residential treatment exceeding six months' duration within the
25 preceding year; or

26 (c) Has been unable to engage in any substantial gainful activity
27 by reason of any mental disorder which has lasted for a continuous
28 period of not less than twelve months. "Substantial gainful activity"
29 shall be defined by the authority by rule consistent with Public Law

31 (11) "Clubhouse" means a community-based program that provides
32 rehabilitation services and is licensed or certified by the
33 department.

34 (12) "Community behavioral health program" means all
35 expenditures, services, activities, or programs, including reasonable

37 treat substance use disorder, mental illness, or both in the
38 community behavioral health system.

39 (13) "Community behavioral health service delivery system" means
40 public, private, or tribal agencies that provide services

3 funding from public sources.

4 (14) "Community support services" means services authorized,
5 planned, and coordinated through resource management services

27 county council, or county executive having authority to establish a
28 behavioral health administrative services organization, or two or
29 more of the county authorities specified in this subsection which
30 have entered into an agreement to establish a behavioral health
31 administrative services organization.

32 (17) "Department" means the department of health.

33 (18) "Designated crisis responder" has the same meaning as in RCW
34 71.05.020.

35 (19) "Director" means the director of the authority.

36 (20) "Drug addiction" means a disease characterized by a
37 dependency on psychoactive chemicals, loss of control over the amount
38 and circumstances of use, symptoms of tolerance, physiological or

3 (21) "Early adopter" means a regional service area for which all
4 of the county authorities have requested that the authority purchase
5 medical and behavioral health services through a managed care health

7 (22) "Emerging best practice" or "promising practice" means a
8 program or practice that, based on statistical analyses or a well
9 established theory of change, shows potential for meeting the
10 evidence-based or research-based criteria, which may include the use
11 of a program that is evidence-based for outcomes other than those
12 listed in subsection (23) of this section.

13 (23) "Evidence-based" means a program or practice that has been
14 tested in heterogeneous or intended populations with multiple
15 randomized, or statistically controlled evaluations, or both; or one
16 large multiple site randomized, or statistically controlled
17 evaluation, or both, where the weight of the evidence from a systemic
18 review demonstrates sustained improvements in at least one outcome.
19 "Evidence-based" also means a program or practice that can be
20 implemented with a set of procedures to allow successful replication
21 in Washington and, when possible, is determined to be cost-

23 (24) "Indian health care provider" means a health care program
24 operated by the Indian health service or by a tribe, tribal

27 (25) "Intensive behavioral health treatment facility" means a
28 community-based specialized residential treatment facility for
29 individuals with behavioral health conditions, including individuals
30 discharging from or being diverted from state and local hospitals,
31 whose impairment or behaviors do not meet, or no longer meet,
32 criteria for involuntary inpatient commitment under chapter 71.05
33 RCW, but whose care needs cannot be met in other community-based

35 (26) "Licensed or certified behavioral health agency" means:

36 (a) An entity licensed or certified according to this chapter or
37 chapter 71.05 RCW;

38 (b) An entity deemed to meet state minimum standards as a result

40 recognized and having a current agreement with the department; or

1 (c) An entity with a tribal attestation that it meets state

4 (27) "Licensed physician" means a person licensed to practice

7 (28) "Long-term inpatient care" means inpatient services for
8 persons committed for, or voluntarily receiving intensive treatment
9 for, periods of ninety days or greater under chapter 71.05 RCW.

10 "Long-term inpatient care" as used in this chapter does not include:

11 (a) Services for individuals committed under chapter 71.05 RCW who
12 are receiving services pursuant to a conditional release or a court-
13 ordered less restrictive alternative to detention; or (b) services
14 for individuals voluntarily receiving less restrictive alternative
15 treatment on the grounds of the state hospital.

16 (29) "Managed care organization" means an organization, having a
17 certificate of authority or certificate of registration from the

22 (30) "Mental health peer respite center" means a peer-run program
23 to serve individuals in need of voluntary, short-term, noncrisis
24 services that focus on recovery and wellness.

25 (31) Mental health "treatment records" include registration and
26 all other records concerning persons who are receiving or who at any
27 time have received services for mental illness, which are maintained
28 by the department of social and health services or the authority, by
29 behavioral health administrative services organizations and their
30 staffs, by managed care organizations and their staffs, or by
31 treatment facilities. "Treatment records" do not include notes or
32 records maintained for personal use by a person providing treatment
33 services for the entities listed in this subsection, or a treatment
34 facility if the notes or records are not available to others.

35 (32) "Mentally ill persons," "persons who are mentally ill," and

38 (33) "Recovery" means a process of change through which
39 individuals improve their health and wellness, live a self-directed
40 life, and strive to reach their full potential.

1 (34) "Research-based" means a program or practice that has been
2 tested with a single randomized, or statistically controlled
3 evaluation, or both, demonstrating sustained desirable outcomes; or
4 where the weight of the evidence from a systemic review supports
5 sustained outcomes as described in subsection (23) of this section
6 but does not meet the full criteria for evidence-based.

7 (35) "Residential services" means a complete range of residences
8 and supports authorized by resource management services and which may
9 involve a facility, a distinct part thereof, or services which
10 support community living, for persons who are acutely mentally ill,
11 adults who are chronically mentally ill, children who are severely
12 emotionally disturbed, or adults who are seriously disturbed and
13 determined by the behavioral health administrative services
14 organization or managed care organization to be at risk of becoming

13 (b) Has been on conditional release status, or under a less
14 restrictive alternative order, at some time during the preceding two
15 years from an evaluation and treatment facility or a state mental
16 health hospital;

17 (c) Has a mental disorder which causes major impairment in
18 several areas of daily living;

19 (d) Exhibits suicidal preoccupation or attempts; or

20 (e) Is a child diagnosed by a mental health professional, as

23 school or with peers or is clearly interfering with the child's
24 personality development and learning.

25 (40) "Severely emotionally disturbed child" or "child who is

28 managed care organization, if applicable, to be experiencing a mental
29 disorder as defined in chapter 71.34 RCW, including those mental
30 disorders that result in a behavioral or conduct disorder, that is
31 clearly interfering with the child's functioning in family or school
32 or with peers and who meets at least one of the following criteria:

19 (i) Licensed or certified behavioral health agencies for the

25 (42) "Substance use disorder" means a cluster of cognitive,

3 (3) "Capacity" means that an adult has not been found to be
4 incapacitated pursuant to this chapter or RCW 11.88.010(1)(e).

5 (4) "Court" means a superior court under chapter 2.08 RCW.

6 (5) "Health care facility" means a hospital, as defined in RCW
7 70.41.020; an institution, as defined in RCW 71.12.455; a state
8 hospital, as defined in RCW 72.23.010; a nursing home, as defined in
9 RCW 18.51.010; or a clinic that is part of a community mental health
10 service delivery system, as defined in RCW 71.24.025.

11 (6) "Health care provider" means an osteopathic physician (~~(or~~
12 ~~osteopathic physician's assistant)~~) licensed under chapter 18.57 (~~(or~~
13 ~~18.57A)~~) RCW, a physician or physician's assistant licensed under
14 chapter 18.71 or 18.71A RCW, or an advanced registered nurse
15 practitioner licensed under RCW 18.79.050.

16 (7) "Incapacitated" means an adult who: (a) Is unable to
17 understand the nature, character, and anticipated results of proposed
18 treatment or alternatives; understand the recognized serious possible
19 risks, complications, and anticipated benefits in treatments and
20 alternatives, including nontreatment; or communicate his or her
21 understanding or treatment decisions; or (b) has been found to be
22 incompetent pursuant to RCW 11.88.010(1)(e).

23 (8) "Informed consent" means consent that is given after the
24 person: (a) Is provided with a description of the nature, character,
25 and anticipated results of proposed treatments and alternatives, and
26 the recognized serious possible risks, complications, and anticipated
27 benefits in the treatments and alternatives, including nontreatment,
28 in language that the person can reasonably be expected to understand;

31 (9) "Long-term care facility" has the same meaning as defined in

33 (10) "Mental disorder" means any organic, mental, or emotional

37 written document in which the principal makes a declaration of
38 instructions or preferences or appoints an agent to make decisions on

3 (12) "Mental health professional" means a psychiatrist,

7 (30) "Professional person in charge" or "professional person"
8 means a physician, other mental health professional, or other person

18 direction has the same force and effect as if communicated directly
19 by the delegating physician or authorized practitioner. Nothing in
20 this provision limits the authority of a licensed nurse, pharmacist,
21 or physician to delegate to an authorized agent, including but not
22 limited to delegation of operation of a facsimile machine by
23 credentialed facility staff, to the extent consistent with his or her
24 professional license.

27 (1)(a) "Sale at retail" or "retail sale" means every sale of
28 tangible personal property (including articles produced, fabricated,
29 or imprinted) to all persons irrespective of the nature of their
30 business and including, among others, without limiting the scope
31 hereof, persons who install, repair, clean, alter, improve,
32 construct, or decorate real or personal property of or for consumers
33 other than a sale to a person who:

34 (i) Purchases for the purpose of resale as tangible personal
35 property in the regular course of business without intervening use by
36 such person, but a purchase for the purpose of resale by a regional
37 transit authority under RCW 81.112.300 is not a sale for resale; or

38 (ii) Installs, repairs, cleans, alters, imprints, improves,
39 constructs, or decorates real or personal property of or for

1 consumers, if such tangible personal property becomes an ingredient
2 or component of such real or personal property without intervening
3 use by such person; or

4 (iii) Purchases for the purpose of consuming the property
5 purchased in producing for sale as a new article of tangible personal
6 property or substance, of which such property becomes an ingredient
7 or component or is a chemical used in processing, when the primary
8 purpose of such chemical is to create a chemical reaction directly
9 through contact with an ingredient of a new article being produced
10 for sale; or

11 (iv) Purchases for the purpose of consuming the property
12 purchased in producing ferrosilicon which is subsequently used in
13 producing magnesium for sale, if the primary purpose of such property
14 is to create a chemical reaction directly through contact with an
15 ingredient of ferrosilicon; or

16 (v) Purchases for the purpose of providing the property to
17 consumers as part of competitive telephone service, as defined in RCW
18 82.04.065; or

19 (vi) Purchases for the purpose of satisfying the person's
20 obligations under an extended warranty as defined in subsection (7)
21 of this section, if such tangible personal property replaces or
22 becomes an ingredient or component of property covered by the
23 extended warranty without intervening use by such person.

24 (b) The term includes every sale of tangible personal property
25 that is used or consumed or to be used or consumed in the performance
26 of any activity defined as a "sale at retail" or "retail sale" even
27 though such property is resold or used as provided in (a)(i) through
28 (vi) of this subsection following such use.

29 (c) The term also means every sale of tangible personal property
30 to persons engaged in any business that is taxable under RCW
31 82.04.280(1) (a), (b), and (g), 82.04.290, and 82.04.2908.

32 (2) The term "sale at retail" or "retail sale" includes the sale
33 of or charge made for tangible personal property consumed and/or for
34 labor and services rendered in respect to the following:

35 (a) The installing, repairing, cleaning, altering, imprinting, or
36 improving of tangible personal property of or for consumers,
37 including charges made for the mere use of facilities in respect
38 thereto, but excluding charges made for the use of self-service
39 laundry facilities, and also excluding sales of laundry service to

1 nonprofit health care facilities, and excluding services rendered in
2 respect to live animals, birds and insects;

3 (b) The constructing, repairing, decorating, or improving of new
4 or existing buildings or other structures under, upon, or above real
5 property of or for consumers, including the installing or attaching
6 of any article of tangible personal property therein or thereto,
7 whether or not such personal property becomes a part of the realty by
8 virtue of installation, and also includes the sale of services or
9 charges made for the clearing of land and the moving of earth
10 excepting the mere leveling of land used in commercial farming or
11 agriculture;

12 (c) The constructing, repairing, or improving of any structure
13 upon, above, or under any real property owned by an owner who conveys
14 the property by title, possession, or any other means to the person
15 performing such construction, repair, or improvement for the purpose
16 of performing such construction, repair, or improvement and the
17 property is then reconveyed by title, possession, or any other means
18 to the original owner;

19 (d) The cleaning, fumigating, razing, or moving of existing
20 buildings or structures, but does not include the charge made for
21 janitorial services; and for purposes of this section the term
22 "janitorial services" means those cleaning and caretaking services
23 ordinarily performed by commercial janitor service businesses
24 including, but not limited to, wall and window washing, floor
25 cleaning and waxing, and the cleaning in place of rugs, drapes and
26 upholstery. The term "janitorial services" does not include painting,
27 papering, repairing, furnace or septic tank cleaning, snow removal or
28 sandblasting;

29 (e) Automobile towing and similar automotive transportation
30 services, but not in respect to those required to report and pay
31 taxes under chapter 82.16 RCW;

32 (f) The furnishing of lodging and all other services by a hotel,
33 rooming house, tourist court, motel, trailer camp, and the granting
34 of any similar license to use real property, as distinguished from
35 the renting or leasing of real property, and it is presumed that the
36 occupancy of real property for a continuous period of one month or
37 more constitutes a rental or lease of real property and not a mere
38 license to use or enjoy the same. For the purposes of this
39 subsection, it is presumed that the sale of and charge made for the
40 furnishing of lodging for a continuous period of one month or more to

1 a person is a rental or lease of real property and not a mere license
2 to enjoy the same;

3 (g) The installing, repairing, altering, or improving of digital
4 goods for consumers;

5 (h) Persons taxable under (a), (b), (c), (d), (e), (f), and (g)
6 of this subsection when such sales or charges are for property, labor
7 and services which are used or consumed in whole or in part by such
8 persons in the performance of any activity defined as a "sale at
9 retail" or "retail sale" even though such property, labor and
10 services may be resold after such use or consumption. Nothing
11 contained in this subsection may be construed to modify subsection
12 (1) of this section and nothing contained in subsection (1) of this
13 section may be construed to modify this subsection.

14 (3) The term "sale at retail" or "retail sale" includes the sale
15 of or charge made for personal, business, or professional services
16 including amounts designated as interest, rents, fees, admission, and
17 other service emoluments however designated, received by persons
18 engaging in the following business activities:

19 (a) Abstract, title insurance, and escrow services;

20 (b) Credit bureau services;

21 (c) Automobile parking and storage garage services;

22 (d) Landscape maintenance and horticultural services but
23 excluding (i) horticultural services provided to farmers and (ii)
24 pruning, trimming, repairing, removing, and clearing of trees and
25 brush near electric transmission or distribution lines or equipment,
26 if performed by or at the direction of an electric utility;

27 (e) Service charges associated with tickets to professional
28 sporting events;

29 (f) The following personal services: Tanning salon services,
30 tattoo parlor services, steam bath services, turkish bath services,
31 escort services, and dating services; and

32 (g) (i) Operating an athletic or fitness facility, including all
33 charges for the use of such a facility or for any associated services
34 and amenities, except as provided in (g) (ii) of this subsection.

35 (ii) Notwithstanding anything to the contrary in (g) (i) of this
36 subsection (3), the term "sale at retail" and "retail sale" under
37 this subsection does not include:

38 (A) Separately stated charges for the use of an athletic or
39 fitness facility where such use is primarily for a purpose other than
40 engaging in or receiving instruction in a physical fitness activity;

1 (B) Separately stated charges for the use of a discrete portion
2 of an athletic or fitness facility, other than a pool, where such
3 discrete portion of the facility does not by itself meet the
4 definition of "athletic or fitness facility" in this subsection;

5 (C) Separately stated charges for services, such as advertising,
6 massage, nutritional consulting, and body composition testing, that
7 do not require the customer to engage in physical fitness activities
8 to receive the service. The exclusion in this subsection
9 (3)(g)(ii)(C) does not apply to personal training services and
10 instruction in a physical fitness activity;

11 (D) Separately stated charges for physical therapy provided by a
12 physical therapist, as those terms are defined in RCW 18.74.010, or
13 occupational therapy provided by an occupational therapy
14 practitioner, as those terms are defined in RCW 18.59.020, when
15 performed pursuant to a referral from an authorized health care
16 practitioner or in consultation with an authorized health care
17 practitioner. For the purposes of this subsection (3)(g)(ii)(D), an
18 authorized health care practitioner means a health care practitioner
19 licensed under chapter 18.83, 18.25, 18.36A, 18.57, (~~18.57A,~~)
20 18.71, or 18.71A RCW;

21 (E) Rent or association fees charged by a landlord or residential
22 association to a tenant or residential owner with access to an
23 athletic or fitness facility maintained by the landlord or
24 residential association, unless the rent or fee varies depending on
25 whether the tenant or owner has access to the facility;

26 (F) Services provided in the regular course of employment by an
27 employee with access to an athletic or fitness facility maintained by
28 the employer for use without charge by its employees or their family
29 members;

30 (G) The provision of access to an athletic or fitness facility by
31 an educational institution to its students and staff. However,
32 charges made by an educational institution to its alumni or other
33 members of the public for the use of any of the educational
34 institution's athletic or fitness facilities are a retail sale under
35 this subsection (3)(g). For purposes of this subsection
36 (3)(g)(ii)(G), "educational institution" has the same meaning as in
37 RCW 82.04.170;

38 (H) Yoga, chi gong, or martial arts classes, training, or events
39 held at a community center, park, school gymnasium, college or
40 university, hospital or other medical facility, private residence, or

1 any other facility that is not operated within and as part of an
2 athletic or fitness facility.

3 (iii) Nothing in (g)(ii) of this subsection (3) may be construed
4 to affect the taxation of sales made by the operator of an athletic
5 or fitness facility, where such sales are defined as a retail sale
6 under any provision of this section other than this subsection (3).

7 (iv) For the purposes of this subsection (3)(g), the following
8 definitions apply:

9 (A) "Athletic or fitness facility" means an indoor or outdoor
10 facility or portion of a facility that is primarily used for:
11 Exercise classes; strength and conditioning programs; personal
12 training services; tennis, racquetball, handball, squash, or
13 pickleball; or other activities requiring the use of exercise or
14 strength training equipment, such as treadmills, elliptical machines,
15 stair climbers, stationary cycles, rowing machines, pilates
16 equipment, balls, climbing ropes, jump ropes, and weightlifting
17 equipment.

18 (B) "Martial arts" means any of the various systems of training
19 for physical combat or self-defense. "Martial arts" includes, but is
20 not limited to, karate, kung fu, tae kwon do, Krav Maga, boxing,
21 kickboxing, jujitsu, shootfighting, wrestling, aikido, judo, hapkido,
22 Kendo, tai chi, and mixed martial arts.

23 (C) "Physical fitness activities" means activities that involve
24 physical exertion for the purpose of improving or maintaining the
25 general fitness, strength, flexibility, conditioning, or health of
26 the participant. "Physical fitness activities" includes participating
27 in yoga, chi gong, or martial arts.

28 (4)(a) The term also includes the renting or leasing of tangible
29 personal property to consumers.

30 (b) The term does not include the renting or leasing of tangible
31 personal property where the lease or rental is for the purpose of
32 sublease or subrent.

33 (5) The term also includes the providing of "competitive
34 telephone service," "telecommunications service," or "ancillary
35 services," as those terms are defined in RCW 82.04.065, to consumers.

36 (6)(a) The term also includes the sale of prewritten computer
37 software to a consumer, regardless of the method of delivery to the
38 end user. For purposes of (a) and (b) of this subsection, the sale of
39 prewritten computer software includes the sale of or charge made for
40 a key or an enabling or activation code, where the key or code is

1 required to activate prewritten computer software and put the
2 software into use. There is no separate sale of the key or code from
3 the prewritten computer software, regardless of how the sale may be
4 characterized by the vendor or by the purchaser.

5 (b) The term "retail sale" does not include the sale of or charge
6 made for:

7 (i) Custom software; or

8 (ii) The customization of prewritten computer software.

9 (c)(i) The term also includes the charge made to consumers for
10 the right to access and use prewritten computer software, where
11 possession of the software is maintained by the seller or a third
12 party, regardless of whether the charge for the service is on a per
13 use, per user, per license, subscription, or some other basis.

14 (ii)(A) The service described in (c)(i) of this subsection (6)
15 includes the right to access and use prewritten computer software to
16 perform data processing.

17 (B) For purposes of this subsection (6)(c)(ii), "data processing"
18 means the systematic performance of operations on data to extract the
19 required information in an appropriate form or to convert the data to
20 usable information. Data processing includes check processing, image
21 processing, form processing, survey processing, payroll processing,
22 claim processing, and similar activities.

23 (7) The term also includes the sale of or charge made for an
24 extended warranty to a consumer. For purposes of this subsection,
25 "extended warranty" means an agreement for a specified duration to
26 perform the replacement or repair of tangible personal property at no
27 additional charge or a reduced charge for tangible personal property,
28 labor, or both, or to provide indemnification for the replacement or
29 repair of tangible personal property, based on the occurrence of
30 specified events. The term "extended warranty" does not include an
31 agreement, otherwise meeting the definition of extended warranty in
32 this subsection, if no separate charge is made for the agreement and
33 the value of the agreement is included in the sales price of the
34 tangible personal property covered by the agreement. For purposes of
35 this subsection, "sales price" has the same meaning as in RCW
36 82.08.010.

37 (8)(a) The term also includes the following sales to consumers of
38 digital goods, digital codes, and digital automated services:

39 (i) Sales in which the seller has granted the purchaser the right
40 of permanent use;

1 (ii) Sales in which the seller has granted the purchaser a right
2 of use that is less than permanent;

3 (iii) Sales in which the purchaser is not obligated to make
4 continued payment as a condition of the sale; and

5 (iv) Sales in which the purchaser is obligated to make continued
6 payment as a condition of the sale.

7 (b) A retail sale of digital goods, digital codes, or digital
8 automated services under this subsection (8) includes any services
9 provided by the seller exclusively in connection with the digital
10 goods, digital codes, or digital automated services, whether or not a
11 separate charge is made for such services.

12 (c) For purposes of this subsection, "permanent" means perpetual
13 or for an indefinite or unspecified length of time. A right of
14 permanent use is presumed to have been granted unless the agreement
15 between the seller and the purchaser specifies or the circumstances
16 surrounding the transaction suggest or indicate that the right to use
17 terminates on the occurrence of a condition subsequent.

18 (9) The term also includes the charge made for providing tangible
19 personal property along with an operator for a fixed or indeterminate
20 period of time. A consideration of this is that the operator is
21 necessary for the tangible personal property to perform as designed.
22 For the purpose of this subsection (9), an operator must do more than
23 maintain, inspect, or set up the tangible personal property.

24 (10) The term does not include the sale of or charge made for
25 labor and services rendered in respect to the building, repairing, or
26 improving of any street, place, road, highway, easement, right-of-
27 way, mass public transportation terminal or parking facility, bridge,
28 tunnel, or trestle which is owned by a municipal corporation or
29 political subdivision of the state or by the United States and which
30 is used or to be used primarily for foot or vehicular traffic
31 including mass transportation vehicles of any kind.

32 (11) The term also does not include sales of chemical sprays or
33 washes to persons for the purpose of postharvest treatment of fruit
34 for the prevention of scald, fungus, mold, or decay, nor does it
35 include sales of feed, seed, seedlings, fertilizer, agents for
36 enhanced pollination including insects such as bees, and spray
37 materials to: (a) Persons who participate in the federal conservation
38 reserve program, the environmental quality incentives program, the
39 wetlands reserve program, and the wildlife habitat incentives
40 program, or their successors administered by the United States

1 department of agriculture; (b) farmers for the purpose of producing
2 for sale any agricultural product; (c) farmers for the purpose of
3 providing bee pollination services; and (d) farmers acting under
4 cooperative habitat development or access contracts with an
5 organization exempt from federal income tax under 26 U.S.C. Sec.
6 501(c)(3) of the federal internal revenue code or the Washington
7 state department of fish and wildlife to produce or improve wildlife
8 habitat on land that the farmer owns or leases.

9 (12) The term does not include the sale of or charge made for
10 labor and services rendered in respect to the constructing,
11 repairing, decorating, or improving of new or existing buildings or
12 other structures under, upon, or above real property of or for the
13 United States, any instrumentality thereof, or a county or city
14 housing authority created pursuant to chapter 35.82 RCW, including
15 the installing, or attaching of any article of tangible personal
16 property therein or thereto, whether or not such personal property
17 becomes a part of the realty by virtue of installation. Nor does the
18 term include the sale of services or charges made for the clearing of
19 land and the moving of earth of or for the United States, any
20 instrumentality thereof, or a county or city housing authority. Nor
21 does the term include the sale of services or charges made for
22 cleaning up for the United States, or its instrumentalities,
23 radioactive waste and other by-products of weapons production and
24 nuclear research and development.

25 (13) The term does not include the sale of or charge made for
26 labor, services, or tangible personal property pursuant to agreements
27 providing maintenance services for bus, rail, or rail fixed guideway
28 equipment when a regional transit authority is the recipient of the
29 labor, services, or tangible personal property, and a transit agency,
30 as defined in RCW 81.104.015, performs the labor or services.

31 (14) The term does not include the sale for resale of any service
32 described in this section if the sale would otherwise constitute a
33 "sale at retail" and "retail sale" under this section.

34 (15)(a) The term "sale at retail" or "retail sale" includes
35 amounts charged, however labeled, to consumers to engage in any of
36 the activities listed in this subsection (15)(a), including the
37 furnishing of any associated equipment or, except as otherwise
38 provided in this subsection, providing instruction in such
39 activities, where such charges are not otherwise defined as a "sale
40 at retail" or "retail sale" in this section:

1 (i)(A) Golf, including any variant in which either golf balls or
2 golf clubs are used, such as miniature golf, hitting golf balls at a
3 driving range, and golf simulators, and including fees charged by a
4 golf course to a player for using his or her own cart. However,
5 charges for golf instruction are not a retail sale, provided that if
6 the instruction involves the use of a golfing facility that would
7 otherwise require the payment of a fee, such as green fees or driving
8 range fees, such fees, including the applicable retail sales tax,
9 must be separately identified and charged by the golfing facility
10 operator to the instructor or the person receiving the instruction.

11 (B) Notwithstanding (a)(i)(A) of this subsection (15) and except
12 as otherwise provided in this subsection (15)(a)(i)(B), the term
13 "sale at retail" or "retail sale" does not include amounts charged to
14 participate in, or conduct, a golf tournament or other competitive
15 event. However, amounts paid by event participants to the golf
16 facility operator are retail sales under this subsection (15)(a)(i).
17 Likewise, amounts paid by the event organizer to the golf facility
18 are retail sales under this subsection (15)(a)(i), if such amounts

20 (ii) Ballooning, hang gliding, indoor or outdoor sky diving,
21 paragliding, parasailing, and similar activities;

22 (iii) Air hockey, billiards, pool, foosball, darts, shuffleboard,
23 ping pong, and similar games;

24 (iv) Access to amusement park, theme park, and water park
25 facilities, including but not limited to charges for admission and
26 locker or cabana rentals. Discrete charges for rides or other
27 attractions or entertainment that are in addition to the charge for
28 admission are not a retail sale under this subsection (15)(a)(iv).
29 For the purposes of this subsection, an amusement park or theme park
30 is a location that provides permanently affixed amusement rides,
31 games, and other entertainment, but does not include parks or zoos
32 for which the primary purpose is the exhibition of wildlife, or
33 fairs, carnivals, and festivals as defined in (b)(i) of this
34 subsection;

35 (v) Batting cage activities;

36 (vi) Bowling, but not including competitive events, except that
37 amounts paid by the event participants to the bowling alley operator
38 are retail sales under this subsection (15)(a)(vi). Likewise, amounts
39 paid by the event organizer to the operator of the bowling alley are

1 retail sales under this subsection (15)(a)(vi), if such amounts vary
2 based on the number of event participants;

3 (vii) Climbing on artificial climbing structures, whether indoors
4 or outdoors;

5 (viii) Day trips for sightseeing purposes;

6 (ix) Bungee jumping, zip lining, and riding inside a ball,
7 whether inflatable or otherwise;

8 (x) Horseback riding offered to the public, where the seller
9 furnishes the horse to the buyer and providing instruction is not the
10 primary focus of the activity, including guided rides, but not
11 including therapeutic horseback riding provided by an instructor
12 certified by a nonprofit organization that offers national or
13 international certification for therapeutic riding instructors;

14 (xi) Fishing, including providing access to private fishing areas
15 and charter or guided fishing, except that fishing contests and
16 license fees imposed by a government entity are not a retail sale
17 under this subsection;

18 (xii) Guided hunting and hunting at game farms and shooting
19 preserves, except that hunting contests and license fees imposed by a
20 government entity are not a retail sale under this subsection;

21 (xiii) Swimming, but only in respect to (A) recreational or
22 fitness swimming that is open to the public, such as open swim, lap
23 swimming, and special events like kids night out and pool parties
24 during open swim time, and (B) pool parties for private events, such
25 as birthdays, family gatherings, and employee outings. Fees for
26 swimming lessons, to participate in swim meets and other
27 competitions, or to join a swim team, club, or aquatic facility are
28 not retail sales under this subsection (15)(a)(xiii);

29 (xiv) Go-karting, bumper cars, and other motorized activities
30 where the seller provides the vehicle and the premises where the
31 buyer will operate the vehicle;

32 (xv) Indoor or outdoor playground activities, such as inflatable
33 bounce structures and other inflatables; mazes; trampolines; slides;
34 ball pits; games of tag, including laser tag and soft-dart tag; and
35 human gyroscope rides, regardless of whether such activities occur at
36 the seller's place of business, but not including playground
37 activities provided for children by a licensed child day care center
38 or licensed family day care provider as those terms are defined in
39 RCW (~~(43.215.010)~~) 43.216.010;

1 (xvi) Shooting sports and activities, such as target shooting,
2 skeet, trap, sporting clays, "5" stand, and archery, but only in
3 respect to discrete charges to members of the public to engage in
4 these activities, but not including fees to enter a competitive
5 event, instruction that is entirely or predominately classroom based,
6 or to join or renew a membership at a club, range, or other facility;

7 (xvii) Paintball and airsoft activities;

8 (xviii) Skating, including ice skating, roller skating, and
9 inline skating, but only in respect to discrete charges to members of
10 the public to engage in skating activities, but not including skating
11 lessons, competitive events, team activities, or fees to join or
12 renew a membership at a skating facility, club, or other
13 organization;

14 (xix) Nonmotorized snow sports and activities, such as downhill
15 and cross-country skiing, snowboarding, ski jumping, sledding, snow
16 tubing, snowshoeing, and similar snow sports and activities, whether
17 engaged in outdoors or in an indoor facility with or without snow,
18 but only in respect to discrete charges to the public for the use of
19 land or facilities to engage in nonmotorized snow sports and
20 activities, such as fees, however labeled, for the use of ski lifts
21 and tows and daily or season passes for access to trails or other

13 age eighteen, or that are focused on providing individuals with
14 disabilities or mental illness, the opportunity to participate in a
15 variety of supervised activities.
