- 1 AN ACT Relating to firearms; reenacting and amending RCW
- 2 9.94A.515; adding a new section to chapter 9A.56 RCW; and prescribing
- 3 penalties.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 9A.56 RCW to read as follows:
- 7 (1) A person is guilty of theft of a firearm from a residence,
- 8 store, shop, or sales outlet if he or she commits a theft of any
- 9 firearm from a residence or store, shop, or sales outlet where
- 10 firearms are sold.
- 11 (2) This section applies regardless of the value of the firearm 12 taken in the theft.
- 13 (3) Each firearm taken in the theft under this section is a 14 separate offense.
- 15 (4)(a) For the purposes of this section, "theft" has the same 16 meaning as defined in RCW 9A.56.020.
- 17 (b) The defense allowed against the prosecution for theft under 18 RCW 9A.56.020 shall apply to the crime of theft of a firearm.
- 19 (5) For the purposes of this section, "firearm" means any firearm 20 as defined in RCW 9.41.010.
