## SUBSTITUTE SENATE BILL 6406

- 1 AN ACT Relating to firearm theft; reenacting and amending RCW
- 2 9.94A.515; adding a new section to chapter 9A.56 RCW; and prescribing
- 3 penalties.

- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 9A.56 RCW to read as follows:
- 7 (1) A person is guilty of theft of a firearm from a residence, 8 store, shop, sales outlet, or vehicle if he or she commits a theft of 9 any firearm from a residence, store, shop, or sales outlet where 10 firearms are sold, or from any vehicle.
- 11 (2) This section applies regardless of the value of the firearm 12 taken in the theft.
- 13 (3) Each firearm taken in the theft under this section is a 14 separate offense.
- 15 (4)(a) For the purposes of this section, "theft" has the same 16 meaning as defined in RCW 9A.56.020.
- 17 (b) The defense allowed against the prosecution for theft under 18 RCW 9A.56.020 shall apply to the crime of theft of a firearm.
  - (5) For the purposes of this section:
- 20 (a) "Firearm" means any firearm as defined in RCW 9.41.010.
- 21 (b) "Vehicle" means any vehicle as defined in RCW 46.04.670.
