1 **AN ACT to amend** 20.435 (1) (b) of the statutes; **relating to:** childhood obesity  
2 prevention and management grants and making an appropriation.

*Analysis by the Legislative Reference Bureau*

This bill appropriates \$5,000,000 in fiscal year 2024-25 for the Department of Health Services to administer and award childhood obesity prevention and management grants.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

3 **SECTION 1.** 20.435 (1) (b) of the statutes is amended to read:  
4 20.435 (1) (b) *General aids and local assistance.* The amounts in the schedule  
5 for aids and local assistance relating to public health services and, for grants for  
6 community programs under s. 46.48, and to administer and award childhood obesity  
7 prevention and management grants under s. 253.17. Notwithstanding ss. 20.001 (3)  
8 (a) and 20.002 (1), the department may transfer funds between fiscal years under

1 this paragraph. Except as otherwise provided in this paragraph, all funds allocated  
2 but not encumbered by December 31 of each year lapse to the general fund on the  
3 next January 1 unless carried forward to the next calendar year by the joint  
4 committee on finance.

5 **SECTION 2. Fiscal changes.**

6 (1) GENERAL AIDS AND LOCAL ASSISTANCE. In the schedule under s. 20.005 (3) for  
7 the appropriation to the department of health services under s. 20.435 (1) (b), the  
8 dollar amount for fiscal year 2024-25 is increased by \$5,000,000 to administer and  
9 award childhood obesity prevention and management grants under s. 253.17.
