2023 SENATE BILL 472

September 29, 2023 – Introduced by Senators Stroebel, Felzkowski, Nass, Quinn, Stafsholt and Tomczyk, cosponsored by Representatives Bodden, Allen, Behnke, Binsfeld, Brandtjen, Brooks, Goeben, Gundrum, Gustafson, Michalski, Murphy, O'Connor, Rettinger, Schmidt and Wichgers. Referred to Committee on Shared Revenue, Elections and Consumer Protection.

AUTHORS SUBJECT TO CHANGE

AN ACT to repeal 6.36 (1) (ae) and 343.50 (8) (c) 3.; to amend 6.36 (1) (b) 1. a., 342.06 (1) (eg) and 343.14 (2j); and to create 6.36 (1) (af) of the statutes; relating to: Wisconsin's membership agreement with the Electronic Registration Information Center.

Analysis by the Legislative Reference Bureau

Under current law, the administrator of the Elections Commission is required to enter into a membership agreement with the Electronic Registration Information Center (ERIC) to assist the commission in maintaining Wisconsin's official voter registration list.

This bill terminates Wisconsin's membership agreement with ERIC and directs the administrator of the Elections Commission to undertake all actions necessary and proper to effect that termination. The bill also expressly prohibits the commission and any other state agency from entering into a membership agreement with ERIC.

SECTION 1. 6.36 (1) (ae) of the statutes is repealed.

16	actions necessary and proper to give effect to this subsection.
