## 2019 SENATE BILL 771

February 3, 2020 - Introduced by Senators DARLING, FITZGERALD and WANGGAARD, cosponsored by Representatives OTT, KNODL and SANFELIPPO. Referred to Committee on Judiciary and Public Safety.

\*\*\*AUTHORS SUBJECT TO CHANGE\*\*\*

1     **AN ACT to create** 16.20, 20.505 (1) (e) and 20.505 (1) (eb) of the statutes; **relating**  
2           **to:** grants to political subdivisions for additional policing and strategic  
3           planning to combat crime and making an appropriation.

---

### *Analysis by the Legislative Reference Bureau*

This bill creates two grant programs to be administered by the Department of Administration.

#### ***Grants for additional policing***

The bill authorizes DOA to award one or more grants to a city, village, town, or county for costs associated with additional policing to address automobile theft and carjacking. DOA must give priority to cities, villages, towns, or counties having a higher incidence of automobile theft or carjacking. Grants may be used to cover up to four years of additional policing costs but may not be used to supplant funding that is available from other sources.

Before DOA implements the additional policing grant program, the bill requires DOA to submit a plan for the grant program to the Joint Committee on Finance for approval. The plan must ensure that the grants will be distributed throughout all geographic areas of Wisconsin and in both urban and rural communities.

The bill appropriates \$5,000,000 for the additional policing grant program in the 2019-21 fiscal biennium. The bill also includes a requirement that grant recipients submit reports to DOA describing in detail how grant moneys were expended and the results of such expenditures, including any impact on the number of persons arrested and charged for automobile theft and carjacking.

**SENATE BILL 771*****Grants for strategic planning***

The bill further authorizes DOA to award one or more grants to a city, village, town, or county for costs associated with strategic planning to combat crime. Grants may be used to cover up to two years of strategic planning costs but may not be used to supplant funding that is available from other sources.

Before DOA implements the strategic planning grant program, the bill requires DOA to submit a plan for the grant program to JCF for approval. The plan must ensure that the grants will be distributed throughout all geographic areas of Wisconsin and in both urban and rural communities.

The bill appropriates \$5,000,000 for the strategic planning grant program in the 2019-21 fiscal biennium. The bill also includes a requirement that grant recipients submit a report to DOA describing in detail how grant moneys were expended and the results of such expenditures.

***The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:***

1           **SECTION 1.** 16.20 of the statutes is created to read:

2           **16.20 Grants for additional policing and strategic planning. (1)**

3           DEFINITION. In this section, "political subdivision" means a city, village, town, or  
4           county.

5           **(2) ADDITIONAL POLICING.** (a) From the appropriation under s. 20.505 (1) (e), the  
6           department may award one or more grants to a political subdivision for costs  
7           associated with additional policing to address automobile theft and carjacking  
8           within the political subdivision. In awarding the grants, the department shall give  
9           priority to the political subdivisions having a higher incidence of automobile theft or  
10          carjacking.

11          (b) No political subdivision may have more than a total of 4 years of additional  
12          policing costs funded by grants under par. (a).

1 (c) The department shall ensure that no grant awarded under par. (a) is used  
2 to supplant funding available to the political subdivision from other sources.

3 (d) Each political subdivision that receives a grant under par. (a) shall submit  
4 a report to the department no later than 2 years after receiving the grant and again  
5 no later than 4 years after receiving the grant. Each report shall describe in detail  
6 how the grant moneys were expended and the results of such expenditures, including  
7 any impact on the number of persons arrested and charged for automobile theft and  
8 carjacking in the political subdivision.

9 **(3) STRATEGIC PLANNING.** (a) From the appropriation under s. 20.505 (1) (eb),  
10 the department may award one or more grants to a political subdivision for costs  
11 associated with strategic planning to combat crime within the political subdivision.

12 (b) No political subdivision may have more than a total of 2 years of strategic  
13 planning costs funded by grants under par. (a).

14 (c) The department shall ensure that no grant awarded under par. (a) is used  
15 to supplant funding available to the political subdivision from other sources.

16 (d) Each political subdivision that receives a grant under par. (a) shall submit  
17 a report to the department no later than 2 years after receiving the grant. The report  
18 shall describe in detail how the grant moneys were expended and the results of such  
19 expenditures.

3           **SECTION 3.** 20.505 (1) (e) of the statutes is created to read:

4           20.505 (1) (e) *Grants for additional policing.* Biennially, the amounts in the  
5 schedule for grants to political subdivisions for additional policing under s. 16.20 (2).

6           **SECTION 4.** 20.505 (1) (eb) of the statutes is created to read:

7           20.505 (1) (eb) *Grants for strategic planning.* Biennially, the amounts in the  
8 schedule for grants to political subdivisions for strategic planning to combat crime  
9 under s. 16.20 (3).

10           **SECTION 5. Nonstatutory provisions.**

11           (1) **ADDITIONAL POLICING.** The department of administration shall submit to the  
12 joint committee on finance a plan for the grant program under s. 16.20 (2). The plan  
13 shall ensure that the grants will be distributed throughout all geographic areas of  
14 the state and in both urban and rural communities. The joint committee on finance  
15 may supplement the appropriation under s. 20.505 (1) (e) from the appropriation  
16 under s. 20.865 (4) (a) if the committee approves or modifies and approves the plan  
17 submitted under this subsection. The committee may make a supplementation  
18 under this subsection without finding that an emergency exists under s. 13.101 (3)  
19 (a) 1. If the committee approves or modifies and approves the plan, the department  
20 of administration shall implement the grant program in accordance with the plan as  
21 approved.

22           (2) **STRATEGIC PLANNING.** The department of administration shall submit to the  
23 joint committee on finance a plan for the grant program under s. 16.20 (3). The plan
