3	Whereas, Edward "Ed" Brooks was a lifelong dairy farmer, loan officer, U.S.
4	Army Reserve veteran, loving husband and father, proud grandfather, friend to all,
<b>5</b>	and dedicated public servant; and
6	Whereas, Ed was born on July 1, 1942, in Baraboo, Wisconsin, graduating from
7	Webb High School (Reedsburg) in 1960, and graduating with a B.S. in Agricultural
8	Economics, University of Wisconsin-Madison in 1965; and
9	Whereas, Ed worked as a loan officer for Production Credit Association, and as
10	a county supervisor with the U.S. Department of Agriculture for a short time after
11	graduating from UW-Madison, before returning to the farm and his true passion,
12	dairy farming; and
13	Whereas, Ed had many other roles throughout his career including 18 years as
14	chair of a Wisconsin-based, multi-state dairy product cooperative, Foremost Farms

1	USA, Wisconsin Federation of Cooperatives chair, National Milk Producers Board
2	vice-chair, 4-H Club leader, St. John Lutheran Church Council president; and
3	Whereas, Ed began his foray into public service at the local level, elected to the
4	Reedsburg Town Board in 1979, becoming Town of Reedsburg chair in 1985 and
5	serving in that role for 34 years; and
6	Whereas, Ed was elected to the Wisconsin State Assembly in 2008 and served
7	as a state representative for the 50th Assembly District (which he referred to as the
8	"Best Assembly District" simply because all his constituents made it the best) for five
9	terms, representing Juneau County and parts of Monroe, Richland, Sauk, and
10	Vernon Counties; and
11	Whereas, Ed served as the chairman of the Assembly Committee on Local
12	Government in 2017-18, and chairman of the Assembly Committee on Urban and
13	Local Affairs in 2011-16, championed rural and local affairs—working to see that
14	residents in rural Wisconsin were recognized as a valuable resource to the state, and
15	was an advocate for rural schools, funding for rural broadband and funding for town
16	roads; and
17	Whereas, Ed married his loving wife, Barbara Wolfgram Brooks, in 1966,
18	raising three daughters, Kelli, Lisa, and Julie, together during their marriage of 52
19	years; and
20	Whereas, Ed's life on the farm kept him very busy, but when he did find time
21	to get away, he enjoyed traveling by train, with Barb by his side. There were many
22	adventures on Amtrak, as family time was very important to him, and he genuinely
23	enjoyed visiting with people in the district; and

Whereas, Ed passed away on April 23, 2019, surrounded by his favorite ladies,
 and after a long and hard-fought battle with leukemia, to be forever with his Lord
 and Savior; now, therefore, be it
